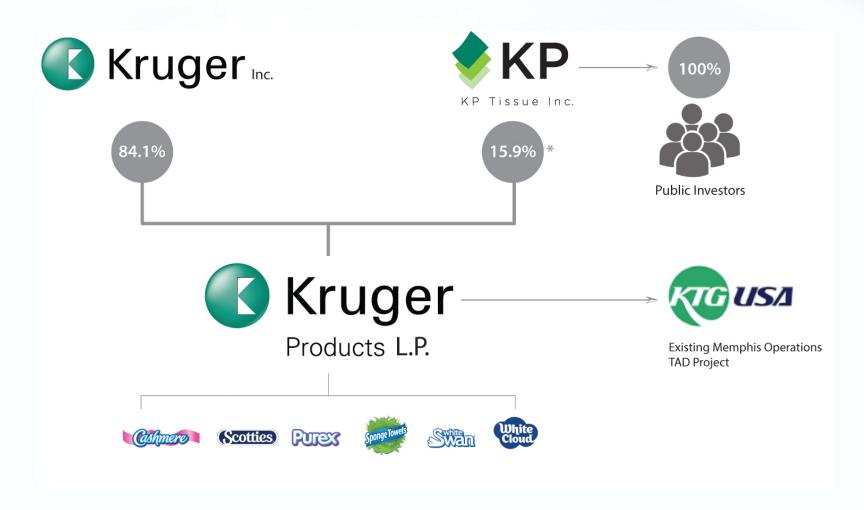

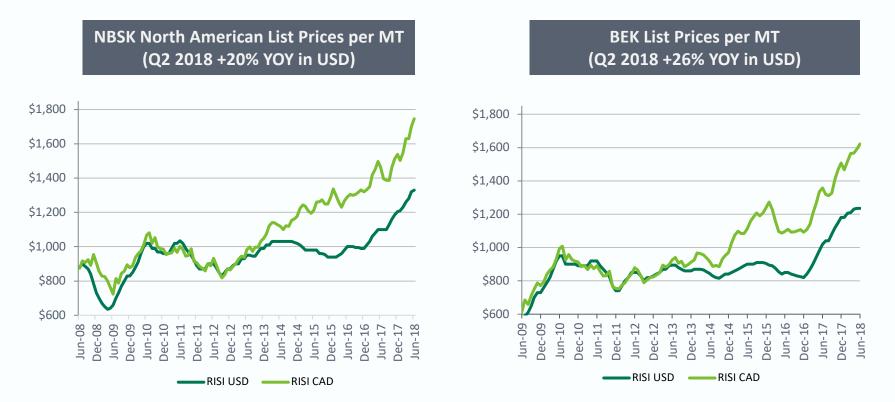

Pulp Input Prices



Q2 2018 market pulp prices rose sequentially compared to Q1 2018, and also year-over-year, in both USD and CAD.

Based on industry forecasts, pulp prices in USD are expected to remain high for the balance of 2018. The volatile CAD will create further fluctuations in pulp input costs.

Freight costs have risen significantly since the beginning of 2017 and reached an all-time high in Q2 2018. Management expects these costs to remain high for the balance of 2018.

The Cass Truckload Linehaul Index™ is an accurate, timely indicator of market fluctuations in per-mile truckload pricing. The index isolates the linehaul component of full truckload costs from other components (e.g. fuel and accessorials), providing an accurate reflection of trends in baseline truckload prices.

Data within this unique index is derived from actual freight invoices paid on behalf of Cass' clients. The index uses January 2005 as its base month.

Price Increase and Cost Reductions



Price increase in Canada consumer

New price increase announced in Canada consumer business in July 2018

Will take effect on October 14 and start to positively impact Q4. Full impact expected in Q1-2019

Input prices rose 23% since the July 2017 selling price increase announcement

Value creation program

Value added program to be much larger in scope and size compared to the past

Smart cost reduction program with no impact on quality aimed at:

- Warehousing cost reduction
- Portfolio mix improvement
- Operating efficiency improvement in the mills
- Optimizing the production network
- SG&A cost reduction

At this time, we are at approximately 80% annualized run-rate of total cost savings expected from this program. We expect to reach 100% by the end of the year.

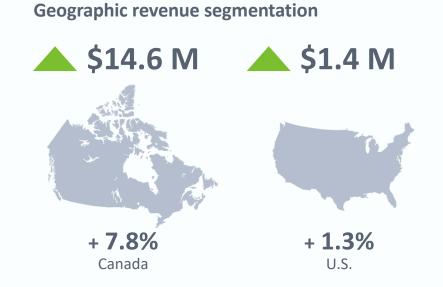

- Favourable impact of increased sales volume
- Consumer selling price increase implemented in Canada in Q4 2017
- Partially offset by unfavourable impact of F/X fluctuations on U.S. sales (USD average 1.29 in Q2 2018 compared to 1.35 in Q2 2017)

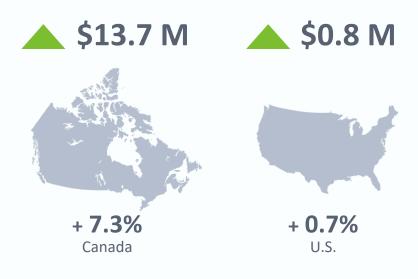

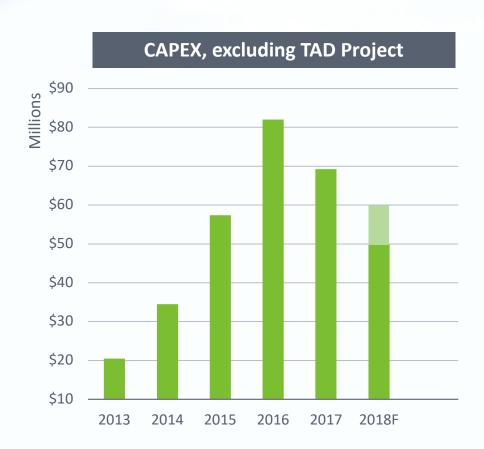

^{*} As of July 1, 2018, the Caisse Facility, which matures on August 16, 2018, has been classified as short-term debt, resulting in a working capital deficit. Subsequent to July 1, 2018, the Partnership has received an extension to September 17, 2018 to repay the Caisse Facility under the same terms and conditions. Management fully expects to refinance the indebtedness prior to the maturity date, unless further extended with approval of the lender. The Partnership is in the final stages of obtaining refinancing of the Caisse Facility with a new lender. Subject to refinancing being obtained, the Partnership believes its cash flows generated from operations combined with its available cash and credit facilities provide sufficient funding to meet its obligations. There can be no assurance that refinancing can be obtained.

^{**} On April 24, 2018, Kruger Products issued CDN \$125 million principal amount of 6.00% Senior Unsecured Notes due April 24, 2025 by way of private placement. Interest on the Notes is payable semi-annually in arrears on April 24th and October 24th of each year, commencing on October 24, 2018. Kruger Products used the net proceeds of the financing to reduce the outstanding balance under its syndicated bank credit facility and to pay transaction costs associated with the Offering.







Q2 2018 CAPEX of \$13.6 million, down from \$25.5 million in Q2 2017 due to the Crabtree project in 2017

2018 focus on high return CAPEX projects – total estimated at \$50 to \$60 million

Cost reduction and Capacity/Growth projects generally have 3 to 4 year paybacks

TAD2 Project



Part of KPLP's long-term strategy is to increase premium paper capacity.

In the final stages for a second TAD paper machine with state-of-the-art converting capability ("TAD2")

The project would require approximately two years for construction and installation following board approval, followed by a ramp-up period for production and sales. Final decision expected in 2018.

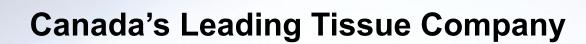
A decision to proceed with the project is subject to a number of factors, including identification of an acceptable site and availability of financing on satisfactory terms

AFH Segment



Resetting the AFH business to create a more efficient manufacturing and logistics footprint:

- Weak results were impacted by pulp prices and freight costs, and also competitive environment
- Select customer price increases with contract renewals
- Absorbs an important amount of fixed costs
- In progress with a multi-year CAPEX program to improve manufacturing and logistics costs
- Crabtree PM8 paper machine is now being partially used for the Consumer segment instead of AFH,
 reducing the beneficial impacts for AFH
- Reset will allow AFH business to become more competitive



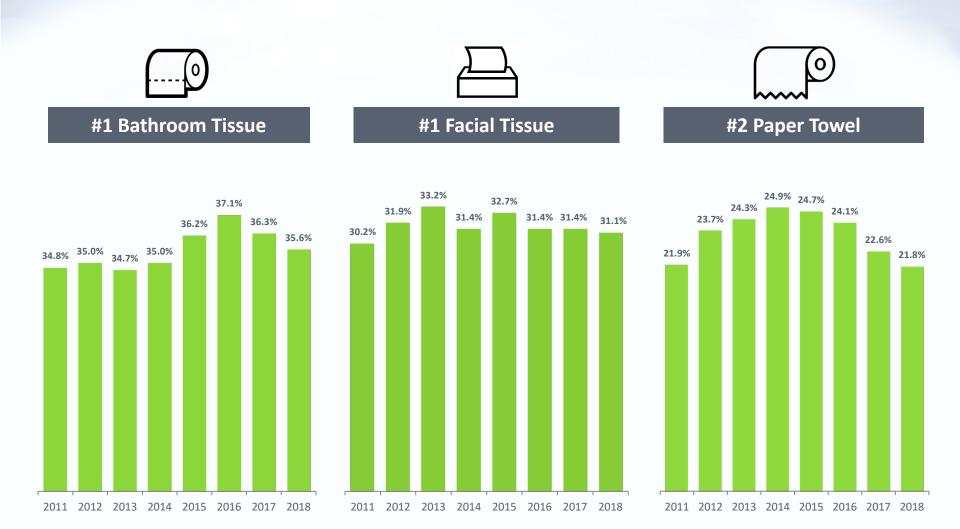

Conclusion



- Continue to build revenue, maintain market share leadership, secure our private label activities, and focus
 on opportunistic growth for AFH
- New price increase in Canada consumer business to take effect starting in Q4-2018
- Initiated an escalated value creation program to partially offset extraordinary short-term market conditions related to pulp and freight costs
- CAPEX in Fiscal 2018 will return to more normal levels after two years of increased investments
- Continue to leverage TAD products market potential and in the final stages for a second TAD machine
- Resetting the AFH business with multi-year program to create a more efficient manufacturing footprint
- In the U.S., continue to build the premium private label business and pursue White Cloud® customer diversification strategy
- KPLP continues to have strong long-term business fundamentals. However, Q3 2018 Adjusted EBITDA is expected to be lower than last year and also reflect normal seasonality
