

OFFICIAL CONTEST RULES AND REGULATIONS

1. KEY DATES:

The Win a Year Supply of IGORA Color Sweepstakes (the “**Contest**”) begins on March 1, 2023 at 12:00 a.m. eastern time (“**ET**”) and ends on April 30, 2023 at 11:59 p.m. ET (the “**Contest Period**”).

2. ELIGIBILITY TO ENTER:

The Contest is open only to residents of Canada who: (a) are a licensed professional hairstylist at the time of entry; and (b) have reached the legal age of majority in their province/territory of residence at the time of entry. Employees, representatives and agents (and those with whom such persons are living, whether related or not) of Henkel Canada Corporation (the “**Sponsor**”) its parent companies, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies and any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfilment of the Contest (collectively, the “**Contest Parties**”) are not eligible to enter or win.

The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification and/or proof of license as a professional hairstylist): (i) for the purposes of verifying an entrant’s eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry and/or other information provided (or purportedly

provided) for the purposes of this Contest (including but not limited to identification for the purpose of proving that you are the account holder); (iii) for the purpose of verifying that the potential winner has fully performed a “salon colour switch” by removing competitor products from the salon; and/or (iv) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of the Contest will be the official time-keeping device(s) used by the Sponsor.

7. PARTICIPATION REQUIREMENTS:

BY PARTICIPATING IN THIS CONTEST, YOU AGREE TO RELEASE THE RELEASED PARTIES FROM ANY AND ALL LIABILITY IN CONNECTION WITH THE CONTEST AND YOUR PARTICIPATION THEREIN AND TO INDEMNIFY THE RELEASED PARTIES AGAINST ANY AND ALL CLAIMS, DAMAGES, LIABILITIES, COSTS, AND EXPENSES ARISING FROM YOUR PARTICIPATION IN THE CONTEST. The Sponsor or its designated representative will make a minimum of two (2) attempts to contact the potential winner via email or phone within three (3) business days of the Selection Date. If a potential winner cannot be contacted within such time, or if there is a return of any notification as undeliverable; then he/she may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to the Prize) and the Sponsor reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate potential winner from among the remaining applicable eligible Entries submitted and received in accordance with these Rules during the Contest Period (in which case the foregoing provisions of this section shall apply to such newly selected potential winner).
