Programs

Autocross Report: Dave reports that our first event was cancelled by NHMS due to a vaccination clinic, our first event will be May 9th. We are figuring out awards for this season and looking at magnetic dash plaques. This Saturday we will be taking inventory of the trailer.

Hillclimb Report: Mike reports that Philo and Okemo are cancelled. Ascutney is not confirmed but not yet cancelled. A budget has been submitted for this year. We are still planning to give first timers a discount and prices are not planned to go up. Brittni reports that we K&K has not been very responsive for insurance, but we are still trying to work that out as the state of Vermont has increased their requirements.

CTTC: Paul reports that things are moving forward, and more info will be out in the next couple weeks. Ian has the backup gear in hand.

TSD Rally: The rally masters are excited and are promising incredible events this year. Events are currently being planned for July, September, and November.

Hillclimb Timing Meeting – Ian reports that we had a successful meeting to refamiliarize the team with the timing hardware and software and prepare for issues we might have on the hill. We will need additional volunteers at CTTC, but our crew knows what they are doing. Ian is also working on headsets for hillclimb that may only need minimal modification.

Winter iRacing League – Calvin reports that we had 14 unique drivers with about 8 running per event. People seemed to enjoy it and it accomplished what I had hoped it would. There's already interest in doing this again next year so I hope we can continue it, with potential to expand beyond iRacing.

Bylaw proposal – Charlie reports that the document is out there and getting comments. We will probably want to wait till we are in person again to discuss it further.
