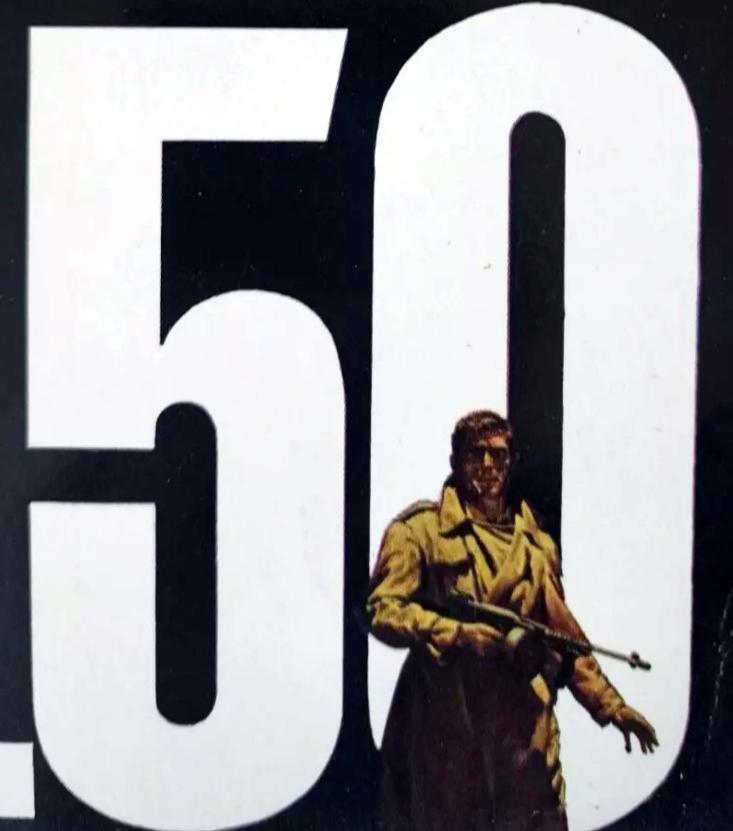

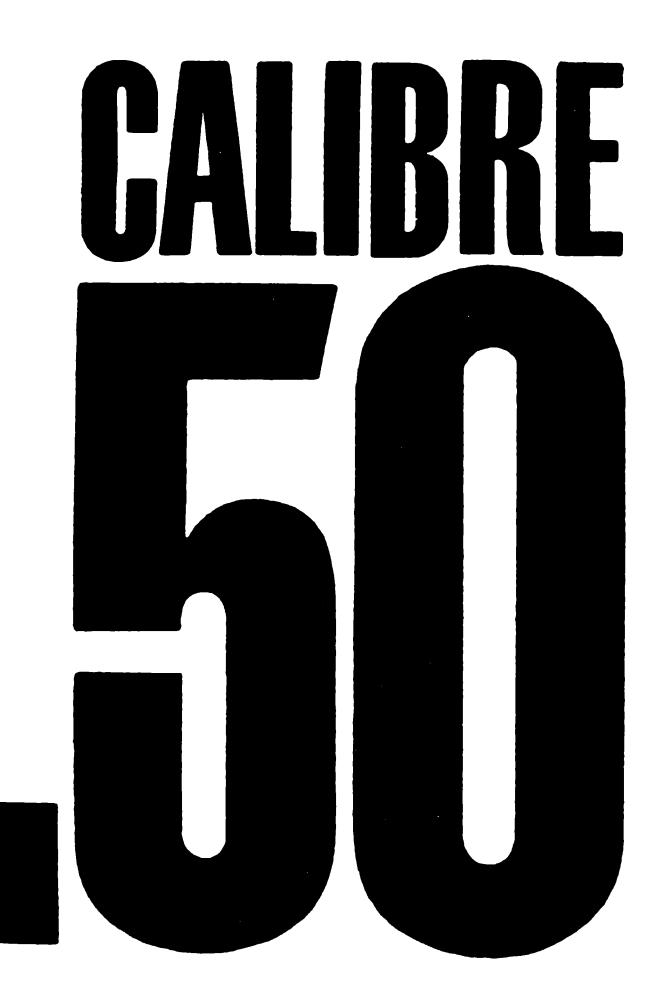

"I heard," Thornton said. "The newspaper I saw in London said the Hollis boy was in critical condition."

"They think he'll pull through now. I saw him in the hospital yesterday and he looks as if he'll pull through. But the policeman is dead."

"Have they any idea who did it?"

"They haven't told me," Ryerson said. "We've had the police department and the D.A.'s office swarming over us ever since the shooting. Insurance investigators. The federal government is investigating. . . . Bill, I think they're going to suspend our trading license."

"Why?"

"There's been too much of this sort of thing going on in Miami. They've been looking for a chance to crack down, make an example of someone."

"But why us?"

"This looks to them like an inside job." Ryerson ticked off the points on his stubby fingers. "According to Hollis, the dispatch slip was in order. It had what looked like my signature. They were after a single shipment which they knew by its shipping number. They knew which warehouse it was in. They knew its scheduled shipping date. During World War II, Spain maintained a cordial neutrality with the Axis powers. It was best to forget Hendaye, to act as though no Spanish troops had fought in the war. The Blue Division was demobilized and its name was struck from the rolls of the Spanish Army. Its commander, General Santos-Figueros, found it expedient to leave Europe. He took up residence in the Dominican Republic.

At the end of the war, Spain had the highest birth rate in Europe, low assets, a minimum of foreign credit, and no good will abroad. Franco encouraged emigration from Spain. One of the few countries which welcomed Spanish immigrants was the Dominican Republic, ruled by Generalissimo Leonidas Trujillo.

During the postwar years, Trujillo's problems had become acute. His people, after more than thirty years of absolute dictatorship, were growing restless. Revolt was in the air, aided and encouraged by examples in Venezuela and Argentina. In revolutionary Cuba, free Dominican forces trained in Oriente Province. Several landings had been made in the Dominican Republic, and had been repelled. But the danger of a successful attack was continually present.

Cuba was the key; but the risks of a war against Cuba were too great. That move had to be avoided at present. Still, a military diversion elsewhere was a definite possibility. It would change the stress; and the establishment of another dictatorship in the Americas would be an asset to the sagging Trujillo regime.

There were no lack of targets. Panama was restless, and Guatemala was unstable. Honduras and Coruna were militarily weak.

Out of these needs and possibilities the Blue Division was reborn. Men came singly and in small groups to the Dominican Republic. The first arrivals were Spanish. But there were Germans from the Wehrmacht, Dutch expelled from Indonesia, landless exiles from Eastern Europe, British and American adventurers, a sprinkling of Canadians and a few French. One and all, they were welcomed to the blue and white eagle. Santos-Figueros began to train his new men. There were

nearly five thousand of them. The Blue Division had become a foreign legion. They were not issued weapons.

General Santos-Figueros was an able and ambitious man. To arm his troops in the Dominican Republic would give him the temptation and the opportunity of overthrowing the Trujillo regime. Even beyond that, the question of arms was complicated. In the past, the Dominican army had been equipped by the United States. This tended to make European calibres uneconomical. But the United States had suddenly and inexplicably stopped shpiping arms to certain dictators. To buy from the Soviet bloc was to court economic retaliation from the United States.
