



## Chapter 1: THE REAL STORY OF SPIES AND SPYING

Spying—or espionage, as it is sometimes called—is as old as history.

Ever since men first banded together to war against each other, they have used spies in order to learn an enemy's weaknesses and strength. Ancient wars and modern wars—except for a single period—all have had their spies. And usually spies are kept at work in peacetime too, gathering whatever information might be useful if, or when, a war occurs.

The one time when spies were not used was in France and England during the Age of Chivalry (about 600 to 1200). The medieval knights of those days valued their honor more than they valued victory. They scorned to win a triumph by anything except courage and strength—and therefore they refused to use spies. They thought

spying was a form of trickery unworthy of their knightly code.

But by 1300 the Age of Chivalry was dying. Once more military leaders began to employ spies. Frederick the Great of Prussia, a few centuries later, thought it was even more important to have a good secret service than to feed his army well.

"When I am in the field," he said, "I have one cook and a hundred spies."

Today, as in the past, there are several different kinds of spies. There are the patriotic spies, who courageously serve their country—and risk their lives—without thought of gain or reward. Sometimes they become national heroes, as Nathan Hale did in the United States.

There are also spies who have no loyalty to any one nation or any one cause, but who are seeking only adventure or gold. They steal secrets as other men steal jewels, for money or for the excitement of outwitting the law. Sometimes they even serve two enemy nations at one time, betraying each to the other and collecting payment from both. Such spies are known as "double agents."

Some of the stories in this book are about spies who made a great deal of money and who lived very adventurous lives. But they are, in fact, exceptions to the rule.

Spying is seldom the adventurous business that it usually appears to be in books or in the movies. During the First World War, for example, when Germany had conquered much of Europe, her enemies—the Allied Nations—established a vast spy network in German-occupied territory. The members of the network had only one important duty: they watched trains.

Hour after hour, seated at a window near a railroad

crossing or hidden in the brush alongside a stretch of track, they counted German troop cars, ambulance cars, ammunition cars, cavalry cars, and supply cars as each one rumbled past, and reported the number of each kind to their superior. When the spies' reports were all fitted together and carefully studied, the Allies had valuable information about German movements toward the front or away from it.

Those spies were performing a vital service, but certainly the work they did could not be considered exciting. And yet this kind of quiet, monotonous "watching," week after week and month after month, is typical of the duties assigned to most secret agents.

Spies who make large amounts of money are also exceptions to the rule. Most people who take up spying in the hope of becoming rich, quickly learn that they have chosen the wrong profession. Spy masters don't have to pay well, because it is too easy to recruit spies. Everywhere there are unhappy people, lonely people, people who have failed in business or in life, who are eager to become spies—no matter how poorly it pays—because they believe it will give them a secret feeling of importance.

Of course, that feeling of importance must always remain secret. A spy who tells the world his business is no longer useful as a spy and may be exposing himself to imprisonment or death. When a spy's name becomes known, it almost always means that he has failed—that he has been caught.

After the Second World War the United States government did honor some of the men who served in its O.S.S.—the Office of Strategic Services, sometimes called "the

cloak and dagger outfit." Some of those men had been parachuted behind enemy lines to gather the information necessary for Allied invasions of North Africa, Italy, and France.

But such recognition hasn't happened very often in the world's history. Usually a successful military commander wants the public to think he won his victories because he was a good general—not because he depended on the aid of clever spies. Usually he conceals the work his spies did for him. And, although almost all countries employ spies, they seldom make heroes of them. The names of spies don't often appear in history books, and not very many of the world's thousands of spies have become famous.

Some of the earliest spies we know by name are the twelve men Moses sent into Canaan before he led the Hebrews into that land. They were, the Bible tells us, Shammua, Shaphat, Caleb, Igal, Oshea, Palti, Gaddiel, Gaddi, Ammiel, Sethur, Nahbi, and Geuel.

The orders Moses gave those men—the orders too are reported in the Old Testament of the Bible—sound very much like instructions still being given to spies today.

"See the land, what it is," Moses told them; "and the people that dwelleth therein, whether they be strong or weak, few or many." He told them to learn whether the land was poor or prosperous, whether it had a good supply of firewood, and whether its people lived in tents or in well-defended strongholds.

There are other spies named in the Bible too. Delilah was one of them. She spied on Samson for the Philistines and received payment from them when she delivered Samson into their hands.

Delilah worked alone. She depended on her beauty,

and on the fact that Samson loved her, to get the information she needed to betray him. Apparently the twelve spies of Moses worked alone too, each one going into a different part of Canaan and bringing his information back direct to Moses himself.

This is an important thing to remember, because it shows us that long ago spies almost always worked alone. A network, or organization, of spies—including collectors of information inside the enemy's territory, couriers to take the information across the enemy's lines, experts to interpret it and fit it together, and sometimes saboteurs too, to destroy enemy supplies and equipment—that kind of organization is a more recent development.

When Alfred the Great wanted to learn the plans of his enemies, the Danes, in about the year 875, he dressed as a wandering minstrel and strolled through the Danish camps until he had picked up all he wanted to know. No ruler today would even think of doing such a thing. Instead, he would assign the job of collecting information to his secret service organization.

So the history of spying is not just a collection of stories about "great" spies—men who pitted their wits and skill against powerful opposition and helped one nation to defeat another. It is also the story of how single spies were organized into today's elaborate network of spies.

For example, there were few famous individual spies in the Second World War. The man known as "Cicero," whose story is told in this book, was one of them. But most of the spies of that war—like the members of the so-called "Sorge ring," which spied for the Soviet Union in Japan—were highly organized groups, in which each man had a special job to do.

About fifteen hundred years ago the Byzantine Empire began to use a terrifying new weapon—a kind of liquid fire which the Byzantines poured down on their attackers from the walls of Constantinople. For four hundred years their enemies tried unsuccessfully to learn how to make that "secret weapon." Today a nation's spy network may learn the secret of an enemy's new weapon within a few months—sometimes even within a few days.

And so today each nation's secrets are protected by an elaborate network of counterspies. These are spies whose duty it is to spy upon enemy agents and expose them before they have accomplished their purpose.

Methods change. Today's spies are as up to date as today's newspapers. They travel by airplane and use microfilm to copy plans and documents. Portable shortwave radio transmitters have become a regular tool of the spying trade. Invisible ink is losing its popularity because modern chemical methods can detect it so easily.

Once spies sought the secret of liquid fire. Today they seek the secrets of atomic weapons.

But spies themselves—the kind of people they are and the purpose behind their work—remain the same. And spies and counterspies, secret agents and double agents, will all probably exist for as long as men go on making war.

Nations are not the only employers of spies. Sometimes an industrial firm employs spies to find out whether its workers are discontented, and to learn what goes on at meetings of the workers' unions and other organizations. These spies are called "labor spies."

There are commercial spies too, hired to ferret out the secrets of a rival company's process or methods of manu-

facture. In the seventeenth century an English nobleman, who owned an ironworks, wanted to learn the method by which certain European craftsmen were making a new metal they called steel. And so, dressed as a shabby musician, the nobleman set out to discover their secret. For months he wandered over Europe. People called him "Fiddler" Foley and never guessed that the gay violinist was really gathering information that would soon make England one of the great steel centers of the world.

But commercial spies and labor spies do not face death as the penalty for failure. Military spies do. Whether they cross into an enemy's country or whether, as traitors to their own country, they stay at home and collect information which they sell to another nation, they are all subject to the harshest punishment a court can impose. Their work may be dull. It may be poorly paid. It may be done for no other reward than the knowledge that a man is serving his own country. But always it is done under the shadow of death or, in peacetime, under the threat of a long term of imprisonment and lifelong disgrace. And therefore all spy stories have a special excitement.

The spy stories in this book—and they are only a few out of the many to be found in the records of espionage—are taken from many different times in history. Some of them end with fame and riches, some with dishonor, some with execution on the gallows or before a firing squad. Some are tales of heroism and patriotic sacrifice. Some are tales of greed and treachery.

They have only one thing in common: all of them really happened. They are all real stories about real spies.



Chapter 2: NATHAN HALE, AMERICAN PATRIOT

It was early in September of the year 1776. The American Colonies were at war with England. At one of the patriots' encampments a handful of officers stood silent around a map-littered table and waited for their commander to speak.

They were the officers of Knowlton's Rangers—a fighting force which had already won a reputation for bravery and daring against the British. Their commander was Colonel Thomas Knowlton himself.

Finally Colonel Knowlton pushed aside the map he had been studying and straightened to his full height of six feet. His eyes were dark with worry.

"Gentlemen," he began, "I have just come from General Washington."

No man in the room needed to be told what Colonel

Knowlton and General George Washington had talked about. They all knew the situation of the American forces and how serious it was.

A few weeks earlier the British had driven Washington's forces from Long Island, back to Manhattan Island and the mainland behind it. Had it not been for a fortunate rainstorm, Sir William Howe's redcoats might very well have captured Washington's entire army and defeated the young American Revolution at a single blow.

"Gentlemen," Knowlton went on, "there is little need for me to explain our difficulties to you. The British now control Brooklyn and as much more of Long Island as they care to occupy. Their batteries on Brooklyn Heights are aimed straight across the water at our defenses on the lower tip of Manhattan Island. They can shatter those defenses whenever it suits their purpose. Their fleet can land men along the New York or the Connecticut coast, behind our lines, and cut us off from the Colonies to the north. General Washington must decide without delay whether we are to entrench ourselves and fight to defend New York, or whether we should abandon the town while there is still time and retreat northward to White Plains."

There was a silence when he finished speaking, and then a murmur of whispers among the men.

"Fight!" a subdued voice said. And another picked it up, "Yes, fight! We must light."

"We are badly outnumbered, gentlemen," Colonel Knowlton reminded them. "Our troops are green and poorly armed. The enemy has the initiative. Right now he can advance whenever and wherever he chooses. It is possible that we could block his next move—but only if we were able to concentrate all our forces at the point of attack. And in order to do that we would have to know the enemy's plans."

He stopped and looked directly at his men, his eyes resting first on one face and then on another.

At last he said, "Gentlemen, General Washington has asked the Rangers to undertake a most unpleasant and dangerous assignment. It is a job for one man—but I will not order any man to accept it. I am asking for a volunteer. His job will be to go to Long Island, observe the British forces there, and obtain all available information about their strength and their plans."

That time the silence that followed his words was broken by a single startled exclamation. "You want one of us to go to Long Island as a spy?"

Colonel Knowlton didn't answer the question with words. The grim look on his face was answer enough.

The men stirred.

"Not I," one of them muttered. "I have no fear of dying like a soldier, but I don't intend to be hanged like a dog."

"Spying is dirty work," another said. "It's no job for officers and gentlemen."

After that no one spoke for a long moment. The silence grew heavy.

"General Washington needs information," Colonel Knowlton said. "He has asked the Rangers to supply it."

The men looked at the maps—looked down at their feet—looked anywhere but at their commander's face.

"I will undertake the mission, sir."

Knowlton glanced swiftly around the room, in search of the man who had spoken those words. The voice had

been young and very low and gentle. The sudden concentrated gaze of the other men directed his eyes to a slender figure standing slightly apart.

Knowlton studied him a moment. "You understand the danger?" he asked quietly. "You know what the penalty would be if you were discovered by the British?"

"Yes, sir. I understand." The voice was still low, but it was steady. "If General Washington needs information, it must be secured. I wish only to be useful, sir, and every kind of service necessary to the public good becomes honorable by being necessary."

"Thank you, Captain Hale." Colonel Knowlton looked into the young man's eyes for an instant. "I will arrange a conference for you with General Washington immediately," he said then, "so that he can tell you exactly what he needs to know."

Nathan Hale's adventure began in that moment—the adventure that would cost him his life and make him one of the best known and best loved of all American heroes.

Almost everyone in the United States can repeat Nathan Hale's last words—the ringing sentence that became a battle cry for a struggling new nation. But no one knows, and probably no one will ever be able to discover, precisely what happened to Captain Hale after he set forth on his dangerous mission into British-held territory that autumn in the fateful year of 1776.

Historians have studied old letters, old documents, yellowed account books, and the official records of the American Revolution. They have unearthed the story of Nathan Hale's youth, his education, and the way he earned his living before the outbreak of the war. But no amount of study has brought to light the events that oc-

curred after Nathan Hale landed on a Long Island beach early one autumn morning just before dawn.

Only from the few facts that do exist and from the study of other known events that took place at the same time is it possible to guess what *probably* happened on Nathan Hale's last military mission.

Nathan Hale was born on June 6, 1755. He was the son of a farmer whose lands lay in the hills of Connecticut about sixty miles from the town of New Haven.

Nathan and his brother Enoch, as boys, were tutored by the Reverend Joseph Huntington. In 1769, when Nathan was fourteen years old and his brother a few years older, they both mounted horses and set off for New Haven to enroll at Yale College—the proud little colonial school that would one day become Yale University.

Nathan was a good student and popular with his classmates. He took part in plays, he wrestled, he was a fleet runner, and an outstanding broad-jumper. The men who knew him in those days said later that they remembered him as a slender but strong young man, quiet and gentle in his manner.

In 1773 both brothers were graduated, and the eighteen-year-old Nathan found a job as schoolmaster in the little village of East Haddam, Connecticut. His second teaching position was in the Union School of New London, a larger Connecticut town already thriving on commerce and shipbuilding. And within a few months after settling there Nathan proved so expert at teaching that he was asked to take charge of the school, at an increased salary.

It must have seemed to the youthful Nathan Hale that he had found his place in life. He liked teaching and he liked New London. Probably he would have been content to spend the rest of his years there in peace and quiet.

But the peace of Connecticut—and the peace of all the American Colonies—was shattered by the gunfire that rang out over Lexington common on the day of April 18, 1775. There had been unrest in certain quarters before that. There had even been talk of rebellion. But on that day the American Revolution actually began.

Nathan Hale believed that teaching was one of the most important things a man could do. He knew that fighting tyranny was even more important. Before the school term was over, he asked the directors of his school to permit him to leave his post. The directors agreed. The Connecticut General Assembly commissioned Nathan Hale almost immediately, as a lieutenant. By the autumn of 1775 he was with Washington's Continental Army, which was then besieging the British in Boston.

The next spring, the spring of 1776, Nathan Hale moved south to New York, along with the rest of Washington's forces. The Americans had compelled the British to abandon Boston. Their next venture was not so successful. They suffered disastrous defeat on Long Island, just off the coast of New York. Nathan Hale was among the thousands of Americans who escaped capture by rowing across the choppy stretch of water to New York, under cover of the rainy darkness.

It was just after that retreat that Colonel Knowlton made Hale a captain in the famous Knowlton Rangers. And it was only two weeks after his promotion that Nathan Hale volunteered to become a spy for his hard-pressed general.

Early in September—it was probably on the twelfth—Nathan Hale left Washington's encampment in Harlem. He had had his conference with General Washington. He had received his instructions.

With Hale when he started out was his orderly, Asher Wright, and a sergeant in Hale's company named Stephen Hempstead.

They went first to the coast, in the hope of being rowed across Long Island Sound to Long Island. General Washington had given Hale a paper, directed to any loyal American boatman to whom Hale might show it, ordering that boatman to row Hale across the Sound. But Hale could find no boatman willing to take the chance.

"There are too many British ships just offshore now," they all said. "It'd be too risky, sir—much too risky."

So Hale and his two companions headed their horses up along the coast. They passed through Rye, in Westchester County, New York, and finally reached Stamford in Connecticut. All along the way they continued to search for a boatman willing to row them across the few miles of water that separated the mainland from Long Island, but all their efforts were fruitless.

Hale finally reached Norwalk, Connecticut, about the fifteenth of September. And there, at last, he found a man who wasn't afraid of the British ships.

That man was a Captain Pond—an old friend of Hale's. The captain knew the waters of the Sound as well as he knew the solid ground of his own backyard. He agreed immediately to take Hale across the Sound and to land him at the village of Huntington on Long Island.

"We'll go at night," he said. "Tomorrow night."

The next day Nathan Hale made his final preparations. He took off his uniform and in its place put on a simple brown suit and a broad-brimmed hat. He removed the silver buckles from his shoes and made sure that he carried no papers that would reveal his true purpose if he were captured.

That evening, when he stepped aboard Captain Pond's sloop, the "Schuyler," Captain Nathan Hale had been transformed into Nathan Hale, schoolmaster. The only paper in his pockets was his diploma from Yale College. It testified that he was indeed what he intended to call himself—a qualified teacher.

There was a last-moment farewell to Hempstead and Wright. There were the subdued creakings of ropes and blocks and the soft whishing of hoisted sails. Then Captain Pond cast off the lines and silently, like a ghost, the sloop nosed its way out into the dark waters of Long Island Sound.

Today a motorboat can make that crossing in very little time. But on that night in 1776 Captain Pond's small vessel needed all the hours of darkness to complete the journey. It was just before daylight when the "Schuyler" dropped anchor and lowered a small boat. A few minutes later the keel of that small boat grated on the pebbles of Huntington beach, and Nathan Hale leaped over the bow to dry land.

He waved a last good-by as the little craft disappeared into the graying darkness and then turned his face landward.

He was in strange territory—enemy territory. He knew no one he could call on for help. But there was no time for hesitation. He saw a path near by. It was a beaten track leading toward the hills looming up not far away. Nathan Hale followed it. It brought him soon to the village of Huntington.

No British military force had appeared in Huntington yet. The little town lay some distance from the British headquarters at Brooklyn, on the shoreward tip of the island, and the British had not yet had time to send soldiers into every hamlet of the island. But Huntington expected British soldiers very soon.

Residents of the village who were still loyal to King George were preparing to greet them with enthusiasm. The American patriots of Huntington were hastily gathering together what few belongings they could carry, in the hope of being able to escape across the Sound to Connecticut.

Nathan Hale began to ask careful questions of the people he encountered along the roadside and in the village.

"The British have already come as far out as Oyster Bay," a farmer told him. "They are demanding wagons to transport their military stores, and. . . ." He broke off to look at Hale curiously. "Who might you be?"

"Just a poor schoolmaster," Hale replied. "I've come here looking for work."

"Well, you'll not find it in Huntington," the farmer assured him. "We've other things to think about than hiring new teachers."

If there were no redcoats in Huntington, Hale could not expect to gather any information about the British there. He began to walk westward toward Oyster Bay, which was some miles closer to Brooklyn.

The village of Oyster Bay stood directly on the Sound

and had a good small harbor. The land around it was rich farming country. When Hale wandered into the neighborhood, he found most of the local farmers busy harvesting their crops and loading their wagons with vegetables, grain, chickens, and cattle. All the wagons then rumbled off to the little port, where boats crowded against the wharves.

The young spy wandered down to the waterfront looking for the explanation of all this feverish activity. Whenever he saw a man standing idle for a moment, he managed to get into conversation with him.

"Schoolteacher?" a boatman repeated, when Hale had answered the man's question about himself. "Where from?"

"Connecticut," Hale told him. "But now I prefer to be in Long Island. Connecticut is no longer a place where loyal British subjects can live in safety."

"Aye." The boatman nodded. "I reckon you're right as to that. Well, there's no place for schoolmasters here now," he went on, "though there's other work aplenty—if you've a mind to roll up your sleeves."

"Why not?" Hale looked interested. "What's the work?"

"We're all busy hereabouts loading and hauling food to the British encampments," the boatman told him. "Hard work it is, but the pay is good."

It must have been difficult for Hale not to jump too quickly at the excellent chance that the boatman's words presented. To visit the British encampments was exactly what Nathan Hale hoped to do. Only there could he obtain the exact details that General Washington wanted—details about the number and type of British guns and

ships, the status of their general supplies, and the number of troops stationed on Long Island, both British and Hessian.

"Just where do you sail?" he asked.

"Wherever on Long Island there are British mouths to feed and British gold to pay for the feeding," the boatman assured him. "We go to Flushing, to Whitestone Landing, and, if the news I hear is true, we'll now cross over to New York as well."

"New York!" That name must have come as a hard blow to the young patriot. "But I thought New York was in rebel hands!"

Had it fallen already to the British? Had the Americans been defeated by the redcoats, or had they retreated without fighting, in the belief that New York could not be held against the king's forces?

The boatman shrugged, unaware of the questions that were teeming in Hale's mind. "We hear that the British have landed at Kip's Bay and that Washington has retreated northward across the Harlem River." Then he shook his head impatiently. "But that matters little to us, eh? If the British are in New York, we'll go there to deliver their food. If not, we'll stay on the Brooklyn side. Either way we'll be paid."

He looked at Hale sharply. "Well? If you want a job, say so." He gestured toward his boat tied up alongside the wharf.

"I do," Hale said quickly. "After all, a schoolteacher must eat. I'm ready to start at once."

"Good. Then come aboard."

Work on the little cargo boat gave Hale just the opportunity he needed. It permitted him to enter the British encampments, to estimate the number of men each contained from the amount of food purchased. He was able to see for himself where the various regiments were located and how many guns they had.

He soon discovered that the rumor the boatman had reported about New York was in fact true. The British had captured the city. They had landed at Kip's Bay on Manhattan Island at the eastern end of present-day Thirty-fourth Street.

The boat Hale was on stopped there to unload cargo. Hale went ashore and wandered through the city, alert for every sign that would tell him the strength of the British occupation. He was able to pick up certain bits of information which he hoped would give General Washington a hint of the enemy's next move.

Fact by fact he added to the store of information in his head, until he began to worry that he would not be able to remember all he had learned. And then he made his mistake—the mistake that would soon put a noose around his neck. He put his information down on paper, and concealed the paper beneath the inner sole of his boot.

He didn't return to his job on the boat. He already had information which he believed General Washington could use. He decided to make his way back to the American lines.

He knew they lay to the north just beyond the Harlem River, only a few miles above the Kip's Bay neighborhood. It must have seemed to Hale that it would be fairly simple to walk in that direction and, under cover of darkness, cross the river to safety. He made ready to set out. An unexpected catastrophe interfered with his plans. On the day Hale started to walk northward a great fire broke out in lower Manhattan. It swept like a prairie fire through the close-ranked buildings of those narrow streets. More than a thousand houses were consumed by the flames.

The British lost valuable supplies and barracks. They declared immediately that spies, sent into New York by Washington, had set the blaze. Squads of redcoats were ordered into the streets, to arrest or kill any person whose behavior seemed suspicious.

Under those desperate circumstances Hale tried to carry out his purpose of reaching the American lines.

At first luck seemed to be with him. He walked, unmolested, as far north as present-day 110th Street. There, finding himself on the easternmost edge of the island—on the shore of the East River—he saw several men in a large rowboat.

Apparently Hale took for granted that they were American patriots. He knew the American lines were not much farther north, and he must have thought that no Britishowned boats would venture so close to them. He decided that it would be safer and probably quicker to continue his northward journey by boat, up the river, instead of by foot. Confidently he called out to the men to inquire about the possibility of using their boat.

The men rowed closer to talk to him. Too late Hale realized that they were enemies. The men belonged to the crew of the British vessel "Halifax," lying at anchor just out of sight behind a near-by island.

The Englishmen asked questions and Hale answered, trying to conceal his real identity. But Nathan Hale was too honest a man to be a good liar. Before he had spoken a dozen words the British grew suspicious. They asked further questions. Hale's replies were floundering. The men in the boat wasted no further time. They seized him on the spot and turned him over to the nearest British sentries.

The sentries took Hale before General Howe, to be searched and questioned further. Almost immediately they found the telltale papers beneath the sole of Hale's boot.

Nathan Hale knew he could never hope to escape the consequences. Further attempts at lying were useless.

"Very well," he said. "I will speak the truth. I am Captain Nathan Hale. I came here as a spy."

"Take him away," Howe ordered. "Turn him over to the Provost Marshal—for hanging in the morning."

The morning of September twenty-second was clear and warm. In an open space in front of Dove's Tavern, at about the spot where Third Avenue crosses 67th Street in New York today, a group of soldiers were hastily preparing a simple gallows and digging a grave in the hard earth.

While they were at work a military guard marched into the open space.

"Halt!" an officer commanded.

The soldiers came to rest. Rifle butts thudded on the packed ground. In the midst of the compact group, surrounded on all sides by the armed men, stood Nathan Hale.

An English officer appeared in the opening of a tent on the edge of the clearing. The troops snapped to attention. "Escort the prisoner to my tent," the officer ordered. "Yes, sir."

It was cool inside the tent. The Englishman pointed to a chair.

"Will you sit down, Captain Hale? It appears that all the preparations have not yet been completed."

"Thank you, Captain. . . . "

"Captain John Montresor," the Englishman said, "of His Majesty's Corps of Engineers."

"Thank you, Captain Montresor." Nathan Hale's voice was as low and gentle as always and as steady.

"Would you like writing materials, Captain Hale?" "Thank you. I would."

For the next few minutes only the sound of pen scratching on paper broke the silence of the tent. Outside soldiers were securing the last knot in the long heavy rope they had looped over the branch of a tall tree. Others were harnessing a team of horses to a farm wagon.

Nathan Hale finished his letters, folded them carefully, and laid them on the table. "Thank you again, Captain Montresor," he said.

A shadow appeared in the doorway of the tent.

"Captain," a voice said, "everything is ready."

Montresor stood up. "Captain Hale, I'm afraid that. . . ."

Hale too rose to his feet. "I'm ready, sir."

With Montresor beside him he walked quickly across the clearing. The wagon had been brought into position directly beneath the dangling noose. Hale climbed into it.

British soldiers bound his hands behind his back and

Their work was finished. They climbed down from the wagon, leaving Nathan Hale there alone.

The British Provost Marshal had arrived to carry out the duty General Howe had assigned to him. His harsh voice sounded loud in the stillness.

"Is there anything you wish to say?" he demanded. Nathan Hale spoke his last words in the same low gentle voice his friends all remembered.

"I only regret," he said steadily, "that I have but one life to lose for my country."

There was a moment of utter silence.

Then the Provost barked an order. A soldier's whip lashed across the backs of the harnessed team. The horses leaped forward, jerking the wagon out from beneath the condemned man's feet.

An instant later Nathan Hale was dead.

The British Provost Marshal was noted for his cruelty to Americans. At his orders Captain Montresor was forced to destroy the last letters Hale had written. But the Provost couldn't erase from the English captain's memory the last words Hale had spoken.

Shortly afterward Captain Montresor crossed the American lines under a flag of truce to arrange for an exchange of prisoners. He told the Americans about Hale's capture and his execution. He spoke of how bravely the young man had died and he repeated those final words.

The words have never been forgotten. They expressed the courage, the loyalty, and the sacrifice of a young nation fighting for its freedom, for its very existence. In the history of espionage Nathan Hale must go down as a failure. He bungled his mission. He was caught and hanged. And the information he collected never reached the hands of General Washington.

But in the history of the United States the young spy has been accorded a hero's place. The British killed Nathan Hale, but they could never kill the devotion to the cause of independence which his death inspired then, and which it still inspires today.



Chapter 3: WASHINGTON'S LONG ISLAND SPIES

NATHAN Hale's mission had ended in death and failure, but it gave the Americans a rallying cry and a hero. It also taught them a lesson which proved of great value. Nathan Hale's tragic end convinced General Washington that what the Americans needed was a competent intelligence service—a well-organized network of spies.

Nathan Hale had worked alone. If there had been other spies at hand to help him, he might have avoided capture, or, at the least, he might have been able to hand over the information he had collected to someone who could ensure its safe delivery.

General Washington knew that if he were going to be able to overcome England's superiority of men and materials, he would need regular and reliable information about the enemy's plans and strength. He decided that he could obtain it only if he had a complete system of spies, couriers, and intelligence experts.

Washington knew it wasn't going to be easy to set up such a system. It would require men courageous enough and clever enough to travel among the enemy—perhaps actually to live among them—without ever revealing their real purpose or their real sympathies. They would have to deceive not only the British but the American Tories—those Americans who favored the English cause—as well. The Tories were only too anxious to prove their loyalty to the crown by reporting anyone suspected of rebellious tendencies. Patriots who undertook the task of gathering and delivering intelligence reports for General Washington would be living under the shadow of the gallows.

But Washington also knew there were patriots brave enough to take those risks, and clever enough to outwit the enemy. He summoned Major Benjamin Tallmadge of the Second Regiment of Light Dragoons to a secret conference—a conference so secret that most of the General's own staff never even heard about it. There he told Tallmadge about the kind of spy network he needed and asked him to organize and direct its activities. It was to be centered in New York, where the British had by then established their headquarters.

The young major of the Dragoons agreed. He had been a classmate of Nathan Hale's at Yale College. The death of his friend had proved to him too that the Americans needed a new and efficient secret service organization.

Tallmadge's first task was to plan a reliable line of communication between New York City itself, where the spies would collect the bulk of their information, and Washington's headquarters north of the British-held island of Manhattan. The two were separated only by a narrow no man's land covering that part of New York City that is today called the Bronx. But Tallmadge knew it would be foolhardy to try to send couriers back and forth across the lines by that route. Instead he worked out a roundabout but much safer method.

He planned to start his couriers out of New York by a route that led *away* from the Americans rather than toward them. It crossed the water to Long Island, that slender body of land that parallels the coast from New York to the northern edge of Connecticut. The couriers would then travel along the island some fifty miles until they reached Setauket. There they could cross back over Long Island Sound to the mainland, arriving in Connecticut at a point safely behind the American lines. This was almost the reverse of the route the unfortunate Nathan Hale had traveled.

The British were in control of Long Island, but Tall-madge knew they couldn't keep a close watch over all its tiny bays and inlets. He had been born on Long Island himself and knew it well. He was certain that near Setauket there were many small harbors that could be safely used by cautious boatmen.

Having decided on his communication lines, Tall-madge recruited his small but fearless band of spies. The four most important men in the group were Robert Townsend—college classmate of Nathan Hale—and Austin Roe, Abraham Woodhull, and Caleb Brewster. A fifth vital member was Anna Strong, the wife of Judge Selah Strong.

Each person in the network had a specific task to

perform. Some were chiefly concerned with collecting information. Others undertook the equally dangerous job of transmitting it.

Tall, handsome young Robert Townsend, a New York merchant who also had a home at Oyster Bay on Long Island, was for some time the chief source of information about British activities in the city.

Austin Roe, a Setauket farmer, served as one of the couriers. His fondness for riding was so well known that no one thought it strange when he made frequent trips from his farm to New York, although fifty-five miles on horseback was too long a trip for most people.

Abraham Woodhull, another Setauket farmer, often traveled to the city to market his produce. Furthermore, he had such a wide acquaintance among his neighbors, patriots and Tories alike, that he could pick up a great deal of information about the British troops stationed on Long Island.

Anna Strong's job was the simplest, but it was no less important than the rest. Almost every time she hung her laundry out to dry she was signaling to Woodhull that Caleb Brewster, the Connecticut boatman, was hiding in a bay waiting for a dispatch which he would deliver across the Sound to Major Tallmadge.

From his post in Connecticut, Major Tallmadge forwarded all the messages he received directly to General Washington or routed back to New York, by way of Long Island, Washington's letters requesting certain information from the spies.

When Washington was stationed just north of New York, Tallmadge could maintain contact with him easily and swiftly. But later, when Washington moved to other parts of the Colonies, Tallmadge had to establish relays of Dragoons at posts fifteen miles apart. Messages traveling in either direction were sent from one post to the next at top speed, whether Washington was in New Jersey or Pennsylvania or was moving southward into Virginia.

Secrecy was the watchword of the entire organization. Few Americans were even aware that the spy network existed. Washington himself was ignorant of the names of all those responsible for the reports that reached him. Only Tallmadge knew all the chief members of his network, but even he didn't know the dozens of patriots who contributed their bit to the store of facts collected for Washington.

The spies used false names. They wrote in invisible ink. They employed codes and ciphers.

The number 711, for example, stood for General Washington, 727 for New York, 729 for Setauket. Robert Townsend was known by the name of Samuel Culper Jr., and Abraham Woodhull was Samuel Culper Sr. The "John Bolton" so often mentioned in the spies' messages was actually Major Tallmadge.

If a spy wanted to send a message like the following:

Caleb Brewster will keep appointment with Abraham Woodhull and John Roberts at Setauket 15 May

he wrote it like this:

725 will keep 28 with 722 and Dqbp Lqfilvu at 729 ek 373

Townsend became kingpin of the network. His business in New York made him well acquainted with many influential Tories. All of them believed Townsend was a Tory himself. His friendship with James Rivington, well-

known publisher of several Tory magazines, proved particularly useful. Townsend often gave Rivington news items for his magazines, and Rivington almost always printed them. When this fact became known, many British officers, who were eager for publicity in order to improve their chances of promotion, made a point of telling Townsend about their plans and their achievements. They even invited him to visit their headquarters and inspect their defense installations. In fact, they revealed all sorts of important data to Townsend, in the hope of seeing their names in print.

Thus Townsend usually had at hand—or could obtain at short notice—most of the information General Washington needed.

The patriot spy network operated with remarkable smoothness. One spring day, for example, relays of swift horses brought Tallmadge a letter from Washington.

At present [the commander in chief wrote] I am anxious to know (for the reports have been very numerous vague and uncertain) whether another embarkation is preparing, and if so to what amount, and where destined. What the present force of the Enemy is; particularly on Long Island, in New York and at King's Bridge. What Corps are at the latter place, how strong, and where posted exactly—and indeed what the situation, prospect, and designs of the enemy are, so far as they can be penetrated into.

Tallmadge immediately sat down and wrote a letter addressed to "Samuel Culper Jr." in New York. The letter sounded perfectly innocent. It simply asked "Culper" to send "John Bolton" some supplies of spices.

When Tallmadge had signed the letter with his code

name, "John Bolton," he waited impatiently for the ink to dry. Then he took from a secret drawer in his desk a small bottle of clear fluid. Dipping his pen in that invisible ink he wrote a second message between the lines of his original letter, listing the things that Washington wanted to know. When he was finished, nothing appeared on the paper except the order for spices.

Then Tallmadge hurried down to the wharf where Caleb Brewster's boat was tied. The letter changed

hands.

"This will go out immediately," Brewster said quietly. "They're expecting me tonight, Major."

Late that night Woodhull, on Long Island, was waiting in the darkness at the head of a silent cove. He heard no sign of Brewster's approach until the small boat scraped gently on the beach.

The letter changed hands again.

"Any trouble?" Woodhull asked.

Brewster chuckled. "There are a couple of British craft out there just begging to be captured. I wasn't looking for trouble on the way over, but I think I'll pick them up on the way back."

And then Brewster set off across the Sound again, as quietly as he had come.

Early the next morning Woodhull left his house. There was plowing to be done in one of his fields—in a field adjoining the pasture land used by his neighbor, Austin Roe. As Woodhull strode along the border of the pasture he paused for a brief instant. When he walked on he no longer was carrying the letter signed "John Bolton." It lay concealed in a hiding place beneath the brush.

Farmer Roe took his cows out to pasture a little later.

He too strolled along the edge of the pasture—and returned to his house with the letter in his pocket. Soon Roe was astride one of his fine horses, pounding the sandy road to New York more than fifty miles away.

By nightfall he was crossing the ferry from Brooklyn to Manhattan, a tired and dusty man.

On dry land again he headed directly for his favorite coffee shop near Wall Street. It was crowded with British redcoats and Tories. The air was full of smoke and military talk. At the far corner a man in civilian clothes sat chatting pleasantly with several officers. He looked up at Roe's arrival, but continued his conversation with no sign of recognition. A few minutes later he got to his feet.

"You'll excuse me, gentlemen," he said politely, "but I have some accounts to balance in my rooms."

"'Tis early, Townsend," one of the officers protested. "The night is young."

"Business, gentlemen," Townsend replied. "It can't wait, you know."

"Well, go if you must. But don't forget, Townsend," the officer added, "you have promised to visit us at our quarters tomorrow. We have an excellent wine we're sure you'd enjoy sampling." He winked. "And a bit of news about our regiment that we think would look well in your friend Rivington's magazine."

"An honor, gentlemen. I won't forget. And now, good night." Townsend bowed and left the coffee shop to go back to his own rooms.

The visitor he was expecting arrived almost immediately. Roe shut the door behind himself and slid the bolt home before he spoke. "Your friend Bolton asked me to deliver this order to you."

"Thank you." The two men smiled at each other, and then Townsend took the letter and read it. "I think I have what he wants," he said. "Spices are scarce just now, but I do have a little."

While he was speaking these innocent sentences for the benefit of any too-curious ears that might somehow overhear him, he was brushing a clear liquid over the surface of the paper before him. Slowly the secret message appeared. Townsend read it carefully.

Then, working as swiftly as possible, he wrote his reply. The visible words he put down answered "John Bolton's" query about the spices. But Townsend too had a bottle of the same kind of invisible ink Tallmadge had used, and once again code words and numbers were invisibly written between the lines. They gave the information Washington had asked for.

When Townsend's reply was ready, he burned "Bolton's" double message. Its secret could now be read. It was too dangerous to keep.

The next morning Roe was galloping back to his farm. Townsend's answer was in his saddlebag, together with little packets of spices. He carried the spices to prove to the British—if road patrols should stop him—that he was simply doing an errand for a friend.

When Roe went to the pasture to bring his cows home that evening he placed the letter in the secret hiding place. Abraham Woodhull picked it up shortly afterward and took it home with him.

He too had information to send on, and so he wrote another letter to be forwarded to Washington with Townsend's. Then he carried his spyglass to a window and peered through it. Just across an inlet, half a mile away, stood Judge Strong's house. Woodhull could see that Anna Strong had washed clothes that day. There was a line of garments hanging up to dry. He strained his eyes in the dusk and made out a black petticoat flanked by three white handkerchiefs.

Woodhull nodded to himself. Anna Strong's message to him was clear. The black petticoat told him that Brewster would arrive again that night from Connecticut. The three handkerchiefs signaled the cove where Brewster would land.

That night a packet containing reports from Townsend and Woodhull—reports signed "Samuel Culper Jr." and "Samuel Culper Sr."—was on its way to Tallmadge. By the following morning it was being speeded south to Washington, carried by Dragoons who spared neither their horses nor themselves.

Most of the time the spy network devoted itself to collecting information for Washington about the British military plans. But on several occasions the secret agents performed other services that were equally important to the winning of the Revolution. One of these occasions had its sinister beginnings in Robert Townsend's pleasant white clapboard home at Oyster Bay.

The British had quartered officers there ever since they had won control of Long Island and New York City. Townsend's sister, Sarah, as tall and handsome as her brother, took care to seem a gracious hostess to her uninvited guests. Neither Colonel John Graves Simcoe, the post commander, or any of the British officers who often visited there, ever suspected the girl of being anything

That evening, not long before dinner was served, Sarah caught sight of an unknown man slinking into her pantry. Before she could ask who he was or what he wanted, the stranger laid a letter on a shelf and vanished through the rear door.

Sarah looked at the letter. It was addressed to a Mr. John Anderson. She had never heard the name before.

Sarah said nothing about the letter to anyone. She simply put it back on the shelf and waited to see what would happen next.

Soon the Colonel's guest, Major André, slipped quietly into the pantry. Apparently he thought no one had seen him. He looked quickly about, saw the letter, put it in his pocket, and then slipped out again.

Sarah was decidedly suspicious. She kept doubly on the alert that night. She heard no one mention the mysterious letter, but she did hear frequent mention of West Point, the American fort on the Hudson River.

Sarah Townsend knew how important West Point was to the Americans. A great quantity of their precious supplies were stored there. And it was, besides, the patriots' chief defense against British attempts to sail northward up the Hudson.

She knew too that the British would give almost anything to capture West Point. Their discussion of it wor-

ried her. It seemed very likely that the British were planning to attack the fort. She decided that her brother must be informed immediately, and that he also should be told about the mysterious letter addressed to John Anderson but silently claimed by Major André.

Unfortunately, however, her brother was in New York as usual. Sarah put her pretty head to work to figure out some way of getting a message to him as quickly as possible. Soon she had an idea. She sought out a young British captain, Daniel Young.

"Captain Young," Sarah said, with a hint of tears in her voice, "I find myself in a most embarrassing position. I'm afraid Colonel Simcoe is going to be very angry with me. He's planning a party for tomorrow, you know, and of course he will expect me to serve that special brand of tea he's so fond of. But my supply of it is completely exhausted. What shall I do?"

The captain looked sympathetic. "Is there none at all to be had, Mistress Sarah?"

"Well, of course, Captain, my brother has some in New York, at his merchant establishment," Sarah told him. "But New York is so far away!"

Captain Young smiled. "It's not so far as all that. I'll dispatch a rider immediately to your brother's place of business. By tomorrow he'll be back with your tea. There—does that solve your problem?"

"Oh, thank you, Captain!" Sarah smiled her most radiant smile. "How clever of you—and how kind! I shall write a note to my brother immediately, telling him exactly what I want—so there shall be no mistake."

While Sarah Townsend was serving the Colonel's favorite tea to a party of British officers the next night, the

news she had sent her brother was already on its way to Tallmadge.

Late in September Tallmadge received word that Americans at Pleasantville, N.Y., had arrested a man who said his name was John Anderson. The captive admitted he was a Tory, but insisted he was not a spy as the Americans believed when they discovered the plans of West Point hidden in his boot. The man had showed a pass signed by the American commander of West Point, Major-General Benedict Arnold.

"Would Major-General Arnold have given me a pass to travel around the country if I were a spy?" the man had demanded.

The Americans who arrested him believed that the pass was a forgery. They decided to send the man to West Point, under guard, to test his story against the word of the fort's commander.

When Tallmadge heard about the case, he acted immediately. He sent his Dragoons out to stop "John Anderson" and his guards and bring the man to him.

Tallmadge was acting only on a brilliant hunch—a hunch based largely on the information Sarah Townsend had offered. At the time he had no idea that "John Anderson" was in reality Major André, the handsome British officer and spy. Nor did Tallmadge know that André had already obtained a promise from the traitor, Benedict Arnold, to turn West Point over to the British.

But because Tallmadge had his secret information and because he acted swiftly, he prevented André from joining Arnold at West Point and making his escape from there through the British lines.

The traitor, Arnold, managed to get away and thus

save his neck. But the vigilance of the patriots' spy ring brought André to his fate. He was convicted of spying and hanged.

Townsend and the other American spies often obtained their valuable information by means of the careless rumors circulating around the British headquarters. But they also knew how to circulate rumors themselves, to the advantage of the American forces.


On one memorable occasion they deliberately spread the false report that Washington intended to attack New York. The British commander heard the rumor and believed it. In fact, he became so alarmed that he refused to send part of his troops to the aid of General Cornwallis at Yorktown, Virginia, when Cornwallis frantically begged for reinforcements.

In the meantime, while the large British force in New York lived in daily fear of the expected American on-slaught, Washington was actually moving his entire army southward to join the attack on Cornwallis.

By the time the British in New York discovered that they had been fooled, it was too late for them to go to Cornwallis's aid. Cornwallis, trapped at Yorktown by Washington's combined forces, surrendered his entire army. The Revolution was practically over, and the rumor circulated by the ingenious patriot spies had hastened its end.

The complete secrecy which protected the Long Island spies from capture and hanging during the war was maintained long after the Revolution was over. Documents that could have revealed the names of those daring men and women were sealed by Washington's order and remained sealed for a hundred years. Only then, a century

after the war's end, could their countrymen know and pay honor to the spies whose intelligence service played such a large part in the successful outcome of the war for independence. Americans still honor those clever, courageous men today.



Chapter 4: THE CHEVALIER D'EON, SPY IN MASQUERADE

He hired the best teacher in Vienna to teach him how to dance, and he bought his clothes from the best tailor. Mack himself introduced him to exclusive officers' clubs, and the small-town smuggler became prominent in Viennese society.

Hostesses quarreled over him. All wanted Shulmeister to attend their gayest parties and their finest dinners.

"He is of noble Hungarian blood, you know," they whispered among themselves. "What a fascinating creature! He seems rather strange at times—but he has such charm! And he dances like a marquis!"

Shulmeister knew what they were saying, and he gloated over every flattering word. He still wanted the Cross of the Legion of Honor more than anything else in the world, but all the other things he had always wanted —money and fame and the society of royalty—he now had in abundance.

And in the meantime he was doing a remarkable secret service job for Napoleon. He felt sure that the Cross of the Legion of Honor would also soon be his.

His daring was almost unbelievable, although he took every precaution to guard his amazing secret. He bribed two of Mack's own men to turn traitor and then privately handed on to them certain bits of false information which he was about to report to Mack. They, in turn, also told Mack what Shulmeister had told them, pretending that they had heard it directly from France. In that way Mack himself received information from three separate persons, and so it never occurred to him that it might not be true.

As the weeks went by Shulmeister built up Mack's confidence in his own forces and steadily wore down the Austrian's fears of Napoleon.

Shulmeister's first task was to convince Mack that Napoleon didn't intend to attack Austria at all. The letters which Shulmeister received from his "spies" in France reported that Napoleon was having so much trouble at

home that he might soon have to give up his plan of conquest abroad.

"The evidence is clear, Marshal," Shulmeister said, handing Mack the letters which he had just received. "This one is from an artillery officer, who says that his guns are all faulty and would be worthless in a battle. And here is another letter—also from an officer—who says that the men in his regiment talk daily of revolting against Napoleon. You can see what the true situation is in the camp of the mad French emperor. He may think he is powerful, but his power is a sham."

Shulmeister also used other tricks besides the letters. He received regularly from France certain newspapers which further built up a picture of trouble in Napoleon's empire. Each paper carried stories about riots and revolts, and reports of French citizens who declared they were dissatisfied with their new emperor.

"You see, Marshal?" Shulmeister said triumphantly. "We need not worry about Napoleon much longer. He has more men against him every day."

The papers, of course, were false. With Napoleon's knowledge and aid, Shulmeister had them especially printed in France for his use and delivered across the border by one of his "spies." But Mack never guessed that the papers were not genuine, and he never doubted anything Shulmeister said.

Finally Napoleon's plans for attacking Austria were almost ready. He sent a secret message to Shulmeister, and Shulmeister quickly staged the final scene in his strange drama of intrigue.

He dashed breathless into Mack's office.

"Marshal!" he said excitedly. "All France is about to

rise against Napoleon! My spies in Paris and Marseille—in every major city of the land—have all sent me special messages reporting this vast revolt! And they tell me that the French armies stationed nearest the Austrian border are all being ordered back to the Rhine. Napoleon needs all the armed men he can collect—and even then he may not be able to put down this great uprising.

"The day of Austria's triumph is at hand, Excellency," Shulmeister hurried on. "Attack now! Follow the French armies as they hurry back toward the Rhine. They will be moving too fast to notice your approach. You will destroy them at a single blow!"

The old Austrian soldier was on his feet. "You bring me good news, Shulmeister," he said. "This is indeed the moment to attack. We must not waste a moment."


Marshal Mack began to issue commands. His 30,000 picked men, long garrisoned in the city of Ulm waiting for the right moment, were ordered to come forth. Within a few hours the entire force was marching toward the spot where the French had been stationed—the spot which, Shulmeister had said, the French had already abandoned in their westward dash.

The gallant Austrians rallied. They stood their ground. But men fell on every side, cut down by the heavy barrage of French fire.

And then Mack realized that there was a second French force on the right of his men and a third on his left! They seemed to have come up out of nowhere—out of the very ground itself. And they were driving toward each other rapidly, enclosing the Austrians in a ring of iron that grew steadily smaller.

The desperate battle raged for three days. Rain fell almost constantly, and the vast battlefield became a sea of mud. Still the Austrians, cut off from any chance of retreat, fought bravely. Soldiers who escaped the French bullets began to drop from exhaustion. Dead men and dead horses piled up amid smoking ruins.

On the third day Marshal Mack, still baffled by the unexpected turn of events, surrendered what was left of his army to Napoleon.

When the Austrian commander finally managed to get back to Vienna he found himself in disgrace. Shulmeister had made a "miraculous escape" through the closing French lines and had returned to Vienna before him. Someone—no doubt it was Shulmeister himself—had convinced the Austrian emperor and his ally, the Tsar of Russia, that Marshal Mack was a traitor to his country. People believed that Marshal Mack had deliberately led

his army to defeat, knowing that the French forces were ready and waiting for him.

Eventually Marshal Mack's friends were able to clear his name. But by then the battle outside the city of Ulm had been followed by an even greater victory for the French. Again the Austrians fell into a neatly planned trap, and the result was Napoleon's famous victory at Austerlitz. It brought the whole of Austria under his control.

Until almost the very day Napoleon marched into Vienna, Shulmeister had managed to evade detection. Somehow, by his charm and his tricks and his daring, he convinced the Austrians that he was still their friend and one of the stanchest fighters for their cause.

They saw through him finally, but only when it was too late. He slipped out of their grasp and returned to Vienna a little later with the powerful title of government censor under Napoleon's regime.

In the years that followed Shulmeister continued to serve his emperor well, sometimes in official posts like the one in Vienna, sometimes on the actual field of battle, but most often as a spy. For Napoleon's sake he lied to thousands of men and helped lead whole armies to their destruction. In his long career Shulmeister deceived and betrayed almost every man he ever met—except Napoleon himself.

Napoleon was grateful for this loyal service. He always paid his spy well. But he never gave him the one thing Shulmeister craved above all—the Cross of the Legion of Honor. Finally Shulmeister persuaded a friend to go to the Emperor and ask him outright to give this special honor to his faithful servant.

Napoleon looked amazed when he heard the request. He had never been ashamed to take advantage of all the tricks that Shulmeister could devise to further the Emperor's dreams of conquest. But Napoleon was shocked—or pretended to be shocked—at the idea that Shulmeister should share some small part of the glory Napoleon had won for himself. Probably, like many military commanders before and since, Napoleon simply didn't want the world to know how much he had depended on the aid of his secret service agent.

"The Cross of the Legion of Honor?" he said to Shulmeister's emissary. "Never. Tell Karl he may have as much gold as he likes—or almost anything else he might want. But I could never bring myself to present that greatest of all honors to a man who is nothing more than a spy."

In many ways Shulmeister was luckier than most spies have been. His career brought him wealth and adventure—two rewards that spying seldom wins. In one way, perhaps, he was even more fortunate than Napoleon. When the "Little Corporal" was finally defeated by England and sent into exile, Shulmeister spent only a short term in prison and suffered the loss of most of his money. He had enough left when he regained his freedom to open a tobacco shop in a small village. There he lived until his peaceful death at the age of eighty-three.

But even Shulmeister never won fame. Napoleon's name is still one of the best known in history. Shulmeister's name is seldom heard. He was doubtless one of the greatest spies of all time, but his fate was the fate of most spies, great and small. He was unhonored in his lifetime. He has been forgotten by history.



## Chapter 6: SPIES IN CRINOLINE

LATE one summer afternoon in the year 1862, a prim little spinster returned home through the shady streets of Richmond, Virginia, capital of the Southern Confederacy. A Negro servant walked respectfully behind her, carrying an empty basket. Earlier that day the basket had held buttermilk and fresh gingerbread. Miss Elizabeth Van Lew had been making one of her regular visits to the sick and wounded Union soldiers in the old Libby Prison.

"Will that be all, Miss Lizzie?" the servant asked, as his mistress lifted her skirt and crinoline petticoats to mount the broad steps of the white-pillared house.

"Yes, thank you. That will be all. But you might tell Martha that I should like her to dust the library in—say—half an hour."

"Yes, ma'am. Yes, Miss Lizzie."

Inside the dusky sweet-scented hall Miss Lizzie put down her parasol and drew off her gloves. Then—though she was tired and would have enjoyed a brief rest—she walked briskly into a book-lined room and sat down at her desk.

For some time she wrote busily, producing a meaningless-looking series of figures. Occasionally she consulted a small piece of paper kept hidden in her watch case.

When she was finished she crossed the room to a handsome fireplace set between two columns. Each column was topped with a small carved figure of a crouching lion.

What she did next took only the briefest moment. Anyone who happened to glance into the room would scarcely have noticed the quick gesture. Miss Lizzie lifted one of the carved lions—it came up in her hand like the lid of a box—and slipped beneath it the sheet on which she had just written. Then she lowered the lion back into place.

A few minutes later, while Miss Lizzie was gathering flowers in her garden, her Negro maid Martha came into the library with a dustcloth in her hand. She too paused only for a moment beside the column on which the small lion crouched. But in that moment she had removed the paper she found there and deftly concealed it within the folds of the dazzling white turban wrapped around her head.

Her dusting of the room was quickly accomplished. Martha had no time to waste. A few minutes later she had hidden the paper once more—this time in a hollow eggshell that shared a basket with other quite innocent eggs.

Shortly afterward, in the hands of another servant, that

basket was on its way out of the city. The servant was prepared to answer any questions that might be put to him. He would declare that he was merely delivering one of the gifts Miss Lizzie so often sent to people less fortunate than herself. The whole town knew how good and kind Miss Lizzie Van Lew was.

That secret opening beneath the carved lion was the first of five "stations" on an elaborate underground railroad over which messages found their way out of the Van Lew mansion. And Miss Lizzie Van Lew—though none of her neighbors ever suspected the amazing truth—was the most important Northern spy in Richmond. In fact, she was one of the most brilliant spies the world has ever known.

General Ulysses S. Grant himself once wrote her gratefully, "You have sent me the most valuable information received from Richmond during the war."

Few historians mention Miss Lizzie, but experts in the field of secret service have studied her methods and admire them greatly. And her services to the Union cause were enormous. She never received—and never asked for—any payment for what she did. Elizabeth Van Lew spied for the North for one reason only. She believed in the North's cause.

Her family had lived in Richmond for a long time. The Van Lew house there was one of the handsomest in that city of handsome homes. But Miss Lizzie had gone to school in Philadelphia when she was a girl, and from Philadelphia Quakers she had learned to hate slavery. When she came home she freed the slaves who belonged to her, and talked constantly against the evils of treating human beings like pieces of personal property.

She was past forty when the War Between the States began, but she still believed as firmly as ever in freedom for all men—and was not afraid to say so. Some of her friends began to call her Crazy Bet. They couldn't believe that a true Southern gentlewoman could actually approve the ideas of the hated Abolitionists, who preached the end of slavery everywhere.

Even those friends who thought Miss Lizzie was a little queer, however, never guessed at her espionage activities. They thought she visited Union soldiers because she was too kind to let even prisoners suffer. It never occurred to them that she received whispered messages from some of those men, and posted the messages quickly on to Union headquarters by means of the code hidden in her dainty watch.

Prominent citizens of Richmond continued to visit the Van Lew home all during the war, and talked freely there of many things which Miss Lizzie promptly repeated in her dispatches to General Grant. Many of her guests were military and political leaders of the rebel South. Miss Lizzie always listened to their remarks with concentrated attention, and she was particularly skillful at piecing together odd bits of information to construct a broad and accurate picture of coming events.

Her genius at managing her underground railroad was especially remarkable. Her couriers were always carefully chosen. One might be a seamstress who knew how to stitch a secret message into the pattern of a dress. Others were faithful servants who had been freed by Miss Lizzie from slavery, and who were more than willing to risk their lives for her. One of the Negroes to whom Miss Lizzie had given both freedom and a good educa-

tion, far away in the North, went to work in the home of Jefferson Davis, president of the Southern Confederacy. The wealth of information she gathered there became a vital part of the North's campaign plans.

Even Miss Lizzie's servants, however, didn't know that there was a secret room in the Van Lew house, close up under the eaves, or that a Union soldier often might lie concealed there for weeks at a time. Miss Lizzie herself would feed her hidden guest with food she took from the kitchen when no one was looking.

And sometimes the courier who carried a bouquet of flowers to the address Miss Lizzie had given him didn't know that the same bouquet would appear on General Grant's breakfast table the next morning—bearing a message of great importance spelled out by a special code of flowers.

Miss Lizzie was never caught. She was still in Richmond when the war ended. A great red, white and blue banner, flying from her window, was the first American flag the triumphant Yankees saw when they entered the defeated rebel stronghold. They cheered the flag, but not even many Northerners knew that the little lady who had put it there was as stanch and brave as any man who carried a gun in the Union ranks.

Some of the other women spies in the War Between the States—and there were many on both sides—were less successful.

Mrs. Rose Greenhow, for example, lived as Miss Lizzie did in the heart of her enemy's capital. The handsome, widowed Mrs. Greenhow was a spy for the Confederacy, and from her home in Washington she served the rebels well during the early days of the war. She too entertained

leaders of the cause she hated, and learned much that was valuable to the Confederate generals. One of her messages was said to be responsible for the South's victory at the Battle of Bull Run.

But Mrs. Greenhow soon came to the attention of Allan Pinkerton, the famous founder of the first detective agency in America and creator of the Union's first military secret service department. Pinkerton watched Mrs. Greenhow himself. Standing in his stocking feet, on the shoulders of a stalwart assistant, he looked through a window into the widow's home and saw her talking with a Union soldier suspected of treachery.

The soldier was questioned. The truth became clear. He and Mrs. Greenhow had been conspiring against the North. Mrs. Greenhow was arrested and jailed in Washington's Old Capitol Prison.

She was released a short time later, however, and sent across the lines into Southern territory. Her only punishment was that she was refused permission to return to the North as long as the war lasted. Most women spies in the War Between the States were treated with equal generosity and chivalry.

This kindly attitude toward spies may seem strange today, but probably it was natural enough in the confusion of a civil war. Many Northern sympathizers lived in the South, and many friends of the South lived in the North. Members of a single family were sometimes divided in their loyalties, and close neighbors often disagreed.

But even a man who distrusted his sister or his neighbor seldom thought of her as a dangerous spy who deserved to be hung. When Northern soldiers marched into

Dixie they took it for granted that the girls and women they saw there would hate the Union cause—but they found it hard to condemn them for that reason.

One young Southerner who learned how to take advantage of this easygoing generosity was the Confederacy's most famous and most beloved spy, young Belle Boyd.

Belle was only seventeen years old when she had her first dramatic meeting with Yankee soldiers. She describes it, and all the other adventures of her spying career, in a book she wrote later. It is called "Belle Boyd in Camp and Prison."

Belle lived in Martinsburg, Virginia, a pleasant little town in the Shenandoah Valley. Her father was a soldier of the Confederacy. Belle and her mother were alone in their house, with the servants, when the Union army captured Martinsburg on July 3, 1861. The next morning Belle awoke to the sound of music. She got up and ran to the window. On the street below a military band was playing, and the soldiers were singing the words of the tune.

Belle recognized it.

"Yankee Doodle!" Her spirited young face grew dark with anger. "That hateful song! They're celebratin' the Fourth of July, that's what they're doin'," she whispered to herself. "How dare they? Right on the doorsteps of folks who hate that holiday now? We don't belong to the Union any more!"

She found a gun when she went downstairs and kept it with her.

"Father's regiment has its own motto, Mother," she said. "The words are on its flag—'Our God, our country and our women.' I mean to show him that women can be

brave too-that we're worthy of our menfolks' courage."

That afternoon a party of Union soldiers tramped up onto the Boyds' porch and banged at the door.

"We're bringing you a Union flag," one of them shouted. "We want you to hoist it on your roof in token of surrender."

Mrs. Boyd opened the door. Belle was close behind her.

"Every member of my household will die before that flag shall be raised over us," Mrs. Boyd declared.

Belle tells us in her book that one of the soldiers then addressed her mother very rudely. Belle's rebel blood reached a boiling point.

She drew out her gun, aimed it swiftly, and fired. The soldier dropped instantly, fatally wounded. He died shortly afterward.

Belle shut the door with a firm hand. She wasn't in the least sorry for what she had done.

And she was perfectly confident a few moments later, when one of the servants ran in, screaming with terror.

"They're goin' to burn down the house, Miss Belle! They're pilin' straw against it! We'll be roasted alive!"

"Here!" Belle scribbled quickly on a piece of paper and handed the note to the servant. "Take this to the Union commander. He won't permit his men to do such a thing—not if he is a true officer. Even the Yankees must have a few gentlemen among them."

The servant fled through a back exit. And soon Belle's note had the result she had expected. The Union commander himself arrived in time to prevent any damage being done to the Boyd house in revenge for the soldier's death.

Then he came into the house to speak to Belle. "I can hardly believe the story I've been told," he said, looking at her slender young figure with amazement. "They tell me you shot a Union soldier."

"Oh, yes, sir. I did." Belle raised herself to her full height. "And I'll tell you why."

She told him what the soldiers had said to her mother and how rudely they had spoken.

"If my father were here he would never permit such words to be used before a woman," she concluded. "But my mother and I are alone. It was up to me. I fired in self-defense."

The commander accepted her story. He posted a guard around the house to make certain that Belle and her mother would not be bothered again.

Belle promptly made friends with the soldiers assigned to the job and with the officers who came by each day on their rounds of inspection. She talked and laughed and flirted with them until they agreed she was the prettiest, sauciest little rebel in Dixie. But behind their backs Belle stole their guns, and she picked up all sorts of information from their conversation.

Both guns and information she sent by trusted messenger to General J. E. B. Stuart—the famous "Jeb" Stuart of the Confederate army.

One of her messages finally fell into Union hands. Belle was brought before a group of Union officers to listen to a solemn reading of the Act of War.

"Giving aid to an enemy of the United States is a crime punishable by death," the commanding officer explained to her. "I am warning you for your own good, Miss Belle."

"Thank you," Belle flashed back. "I'll remember."

She was allowed to return to her home. But after that, she says, she was "incessantly watched and persecuted." She wasn't frightened. She did, however, find it "irksome" to be constantly under suspicion.

Finally she and her mother decided to go to Front Royal, where Belle's aunt lived. Front Royal was still in Confederate hands. There they would be free to live as they wished. They obtained the necessary passes and set out.

While they were on the way the Union army seized Front Royal. The Boyds arrived there to find the aunt's house occupied as headquarters by the Yankee forces. Belle and her mother had to stay in a small house in the yard, where the aunt was allowed to live.

It was a very satisfactory arrangement so far as Belle was concerned. Living next door to the Union commander gave her all sorts of opportunity for spying. Again she made friends with all the soldiers in the neighborhood and kept her eyes and ears open.

One day she learned that a council of war would take place that night in what had once been her aunt's drawing room. Belle slipped secretly into the big house and ran upstairs. She discovered that a closet in one of the bedrooms was directly over the council chamber and that a hole in the closet floor gave her a bird's-eye view of the room below.

That night, when the officers gathered, Belle was crouched in the closet over her peephole. She heard every word that the Union officers said. They talked until one o'clock in the morning, outlining plans for a campaign they were about to launch.

Belle waited, cramped and aching, until the officers went off to their beds. Then she stole downstairs, slipped across the courtyard to her own room, and wrote down in cipher everything she had learned. When she was finished she crossed the dark courtyard once more, this time to the stable. There she saddled a horse and rode off silently into the night, toward the Confederate lines.

Twice Union sentries stopped her on the road. Both times Belle calmly showed them a false pass she had obtained for just such an emergency, and both times they allowed her to proceed.

After a wild ride of fifteen miles she reached the headquarters of the Confederate commander, Colonel Henry Ashby. The Colonel was called from his bed at her arrival. He recognized the young daughter of one of his friends and fellow officers.

"Miss Belle!" he exclaimed. "Is this you? Have you dropped from the clouds? Or am I dreaming?"

"No, Colonel Ashby, you're not dreaming," Belle assured him. "I've come with important information."

It was growing light when Belle finally stabled her horse again in Front Royal. She barely had time to get into bed before the rest of the household awoke.

On another occasion Belle delivered a message to the South's adored leader—and Belle's own particular hero—General "Stonewall" Jackson. It was on the afternoon of May 23, 1862. Belle had looked from her window that day and had seen that there was unusual excitement in the streets. She ran out immediately.

"Whatever is all the fuss about, Sergeant?" she asked the first Union soldier she met.

He answered her curtly. "Old 'Stonewall's' just over

the hill there. We're getting ready to give him a big surprise if he comes any closer." And he ran off down the street.

Belle's heart began to beat faster. She knew what the Sergeant had meant by a "big surprise." There were few Union men in Front Royal just then, but other Union forces were stationed not far away. Belle realized that the Northerners would all soon be alerted, and that if they had time to plan their strategy they would undoubtedly defeat General Jackson.

Supply wagons were rumbling past her. Platoons in orderly ranks were hurrying out to sentry duty.

Belle bit her lip as she walked back into the house. "General Jackson must attack immediately," she told herself, "before they are ready for him. Even an hour's delay will be too much."

She knew then what she had to do. Snatching up a sunbonnet, she ran back into the street and made her way as quickly as possible through the hurrying soldiers. None of them paid any attention to her. For once they were too busy to take time out for a word with that pretty little rebel, Miss Belle.

When she reached the edge of town, she dashed across an open field toward the hill behind which Jackson's army waited.

Already there was skirmishing between the outposts of the two forces. Shells fell near her, but Belle never paused. One thudded so close that she fell flat on the ground, half covered by a shower of clods. But she scrambled up again a moment later and ran on.

She was panting breathlessly when a young Confederate cavalryman rode out to meet her, at the orders of

Jackson himself. "Stonewall" had seen the small running figure and had sent an officer to the girl's rescue.

But Belle didn't need rescue. She began to speak as soon as she could catch her breath.

"Tell him-tell General Jackson-to attack quickly!" she gasped.

She told the officer all she had seen and heard back in Front Royal.

Jackson acted immediately on Belle's information. His Confederate troops dashed down the hill into the town. And the Union men—their trap still unprepared—had to retreat before them.

When Belle herself returned to the village, the streets were already overflowing with triumphant rebels. They greeted her with enthusiastic shouts. And that evening General Jackson sent her a note.

"I thank you," it said, "for myself and for the army, for the immense service that you have rendered your country today."

Northern newspaper accounts of the battle made much of "the little rebel spy" and the part she had played. One extravagant story declared that "La Belle Boyd," as it called her, had led the attack herself, brandishing a sword in her hand.

Belle was famous after that, both in the North and in the South. One result of that fame was probably inevitable. She was arrested and taken to Washington to be jailed in the Old Capitol Prison.

She was—or so she tells us in her book—more angry than frightened. She took one look at the large room to which she was assigned—a room with two windows and a fireplace—and declared it was a "dungeon."

The governor of the prison sent her a servant to wait on her, and Belle asked for a fire too. It was a warm day. The room was quite comfortable. But Belle thought a fire would make it look more cheerful. The governor indulgently agreed.

Her door was never locked, and she was permitted to sit at the threshold and look out into the corridor. All her meals were good. The first night, and almost every night afterward, she had soup, beefsteak, chicken, several vegetables and a dessert of fruit.

Nevertheless, Belle thought she was being very badly treated. She broke the prison regulations whenever she had the chance.

Soon after her arrival she heard a tapping on one wall. A moment later the thin point of a knife pierced through the plaster at that spot. Belle grabbed a knife from her dinner tray and began to chip at the plaster from her side of the wall. Within a few minutes there was a slit big enough to push a note through. From then on Belle communicated regularly with the Confederate prisoners on the other side of that wall.

The prisoner in the room above hers—in the very room Mrs. Greenhow had occupied some months before—sent Belle notes through a chink in his floor. She herself wrote messages on tiny scraps of paper, wrapped them tightly around a marble, and rolled them across the corridor to the men in the cells opposite.

And every evening she sat at the door of her room and sang. "Maryland, My Maryland" was her favorite, and the favorite of the rebels who eagerly applauded her each night. Belle was the heroine of the prison, adored by all who were jailed there and even by many of the guards.

Her sentence ended after several months. With a group of other prisoners who were being exchanged for Union captives held in the South, Belle was sent home under a flag of truce.

The Confederacy honored her with a captain's commission when she returned. She also became an honorary aide-de-camp to General Jackson. Everywhere she traveled through the Southern states, she was royally entertained at parties and dinners in her honor.

Belle was arrested once more during her career, and that time too she was imprisoned in Washington. Again, she set up communications with her fellow prisoners and even with a confederate outside. He shot messages in through her window on the tip of an arrow, and she returned her answers inside a hollow rubber ball.

When she was released the second time, she decided to go to England. Her father had died. Her own health was poor. All her friends urged her to live abroad until the end of the war.

Belle sailed out of Wilmington on the "Greyhound." In her bags were dispatches from Jefferson Davis to the many friends of his cause in England. The "Greyhound" flew a British flag.

Under cover of darkness the ship tried to run through the blockade of Union vessels guarding the harbor mouth. By morning the ship's officers believed they were safely past the danger. But suddenly, out of the lifting fog, they saw a cruiser bearing down on them. Shells began to fall into the water on all sides.

The "Greyhound" was helpless to fight back. The crew flung overboard the ship's cargo—bales of cotton intended for the English market—in order to increase her speed. But the Yankee cruiser continued to gain on her. "Will we get away, Captain?" Belle asked.

The captain of the "Greyhound" shook his head grimly. "We haven't a chance. They'll be alongside in a minute now and sending a boarding party to take us over. I'm sorry, Miss Belle—mighty sorry."

"I'd better burn Jefferson Davis's letters then," Belle said calmly.

When the letters had been destroyed, she waited on deck with the ship's officers while the Yankee cruiser, the "Connecticut," drew up. And she watched as the boarding party climbed over the rail of the "Greyhound" to demand her surrender.

"We'll take over, Captain," one of the officers said. "Our orders are to take your ship to New York."

One of the officers of the "Connecticut" was young Lieutenant Sam Hardinge. And before Belle reached New York in his custody, he had asked her to marry him. She agreed, but on one condition—that he give up his commission in the Federal Navy.

Hardinge met her condition willingly. "My sympathies have always been with the South," he said. "I never really wanted to fight against her, and I'll be glad to stop—especially now."

Belle's career as a spy was over. She was permitted to go on to England by way of Canada, and soon Hardinge met her there. Their marriage in London was sympathetically reported in English newspapers. The London "Morning Post" said,

St. James's Church, Piccadilly, was yesterday the scene of a romantic episode in the fratricidal war now raging on the

American continent; as, at the altar of that sacred edifice, Miss Belle Boyd, whose name and fame are deservedly cherished in the Southern States, pledged her troth to Mr. Sam Wylde Hardinge, formerly an officer in the Federal naval service. The marriage attracted to the church a considerable number of English and American sympathizers in the cause of the South, anxious to see the lady whose heroism has made her name so famous, and to witness the result of her last captivity, the making captive of the Federal officer under whose guard she was again being conveyed to prison.

Belle's husband died shortly after their marriage, but she herself went on to a long and successful career on the stage and as a lecturer. After the war was over, Northern and Southern audiences alike applauded her dramatic recital of her experiences as "the little rebel spy." And after her death, in Wisconsin, her grave was decorated each year by veterans of the Union army—perhaps by some of the very men whom young Belle Boyd had mentioned in her excited dispatches to General "Stonewall" Jackson.

Young Emma Edmonds was another spy of the Civil War who later wrote a book about her experiences. Emma was a Canadian who had come to the United States a few years before the war began, to study nursing. When the fighting started, she immediately offered her services and her loyalty to Abraham Lincoln's government. Her book is called "Nurse and Spy in the Union Army."

Emma was a good and faithful nurse, often working for long hours on the battlefield under fire. Like Belle, she eventually became aide-de-camp to a general, but her appointment was not just an honorary one. She served actively in a mud-streaked soldier's uniform, and her bravery was tried time and time again.

Her spying activities began at the request of Union officers, who recognized her courage and daring. But none of them guessed, until Emma herself proved it, how skillful an actress she could be.

The first time she crossed over the lines into rebel territory, she was disguised as a Negro laborer. The first Confederate officer who noticed her put her right to work, among a group of slaves who were building fortifications. He had no idea that the woolly wigged, blackfaced, shabbily dressed "man" was really a handsome young woman who had left a Union camp only a few hours before.

"Jim," he told a fellow slave, "I'll be darned if that fellow ain't turnin' white!"

Emma overheard him. She scurried quickly out of his sight and looked at herself in a small pocket mirror. The Negro was right. The color she had smeared on her face and neck and hands was beginning to fade very rapidly. Emma knew she couldn't safely remain at her post much longer.

That night there were not enough sentries for duty along the Confederate lines. An officer took Emma away from her task of carrying supper to the troops.

"Here, you," he said. "You come along with me."

He took her some way along the lines and then turned her over to another officer.

"Put this fellow on the post where that man was shot," he said, pushing Emma forward.

The second officer shoved a rifle into Emma's hands.

"Now, you black rascal," he said, "if you sleep on your post I'll shoot you like a dog."

Emma cowered in front of him. "I'se too feared to sleep," she promised.

The night was very dark. Emma, left alone at her post in the black silence, was almost as afraid as she had pretended to be. But she knew what she had to do.

Crouching low and moving very carefully so that she wouldn't snap the twigs or rustle the leaves under her feet, she started across the no man's land toward the Union lines. For hours she made her way forward, yard by stealthy yard. She didn't stop until she felt certain

she must be near the Union pickets. Then she lay down to rest until it grew light.

With the first gleam of dawn she stood up. And as soon as she saw a slight movement somewhere up ahead, she called out the signal which would identify her as a friend. Soon she was walking into the Union camp, still carrying her Confederate rifle as a prize of war.

"Yes, sir," Emma said. "I'll ride around the bend, sir."


She knew her chance had come. She rounded the curve in the road—and kept riding in that direction until she reached the Chickahominy and the safety of her own friends.

But he has also worked in a factory and is very popular with the workingmen, particularly with those who make the most trouble."

"They were protecting you, Sire?" The officer was amazed.

"That is enough." The King's answer was sharp. "Bring Herr Stieber to me. He shall see how we reward faithful subjects."

The King's order that day set in motion the career of a man who was to become one of the greatest spy masters of history.

The police discovered Stieber's treachery before the workers did. The public heard the story too, and there was a great outcry against Stieber.

The head of the police took a firm stand. "The man must go," he said, "even if the King himself appointed him to the job. We can never convict thieves and murderers so long as this treacherous spy is in our midst, using our own records to prevent us from putting criminals where they belong—behind bars."

"Shh!" the first man whispered. "Don't say a word. Stieber's spies are everywhere."

Finally the King's mental condition became so serious that he was put in a private asylum. His brother William took over the reins of the Prussian government.

All over Berlin men heaved a sigh of relief. William, they thought, would never put up with Stieber. Now at last the hated spy would go.

And William did get rid of Stieber, but not in the way his subjects expected him to. William didn't have the spy arrested. Instead he had him brought to his private chambers. William knew Stieber was dangerous, but he also knew the man was clever. He intended to make use of that cleverness.

"Stieber," William said, "I have decided that it would be wise for you to leave Prussia for a time. I suggest that you go to Russia. Our friend the Tsar needs a man of your talents. I shall recommend you to him."

Stieber bowed low. "Your word is my command, Sire."

"Of course," William continued, "you will never forget that your first allegiance is to us. In Russia you may have the chance to learn things that would interest us. And if so . . . ."

"I understand fully, Sire." There was a sly smile on Stieber's face as he bowed himself out.

Stieber worked for the Tsar of Russia for five years. And he had plenty of work to do. The Russian people were even more oppressed than the workers of Prussia. Russian peasants were little better than slaves. And they were beginning to grumble, beginning to mutter of revolt. The Tsar lived in constant fear of an uprising, and he turned to Stieber to protect him. He gave his new spy a free hand and plenty of money to work with.

Stieber promptly set up the Russian Secret Service—a powerful and efficient organization that would strike terror into Russian hearts for years to come. Again his spies were everywhere. Russian workers were arrested by the hundreds and sent to Siberia, often without even a trial. Those who tried to flee the country were hunted down in the farthest corners of Europe.

It was good practice for Stieber. He was ready to take on an equally important job for Prussia, when he was called back there.

The man who set Stieber to work again in his homeland was Prince Otto Leopold von Bismarck, Prussia's new chancellor. Bismarck himself was a master of intrigue, and when William named him Chancellor, Bismarck began immediately to plan important political moves and future wars. His dream was to bind Prussia and all the other small German states into one vast German Empire, with William as its emperor.

Bismarck was a huge, powerful man, with shaggy eyebrows and a massive head. He towered over Stieber. But the first time he met the spy, he knew that he wanted the small, sly man's help.

"Stieber," Bismarck said, "I want to know everything there is to know about the Austrian army. I think you are the man to get the information for me."

"That would take time, Excellency," Stieber said.

"You will be given time," Bismarck told him. "I am not yet in too great a hurry." He looked at Stieber solemnly. "I am laying my plans well. This is only the first move in a great program. I intend to establish the German Empire and make it the greatest empire in the world. Nothing must be allowed to stand in the way. Nothing! I will not ask how you do your job. I ask only that you do it well. Success will win you rich rewards and the thanks of a grateful country—a grateful and powerful country," he added.

"I will not fail, Excellency," Stieber promised him. He kept his word.

He grew a beard. He bought a wagon and a team of horses. He purchased a huge supply of cheap religious pictures, trinkets, and various odds and ends. Then, slouched on the seat of his loaded wagon, he crossed the border into Austria as a peddler.

For three years he wandered. He sold his wares to peasants—and while he did, he noted the state of their crops and the state of the roads. The servants took jobs in the homes of important people, including some of the military and political leaders of France. The waitresses began to serve in French cafés. The handymen worked at inns and at army posts.

All of them were trained to listen to conversations and to remember anything of importance that they might hear. All of them spent their free time walking around their new neighborhoods, studying railroad trains, bridges, and army installations.

Altogether, it is said, there were 40,000 German spies working for Stieber in France at that time.

Stieber collected the information from them himself. He made a complete tour of France, visiting every city and every hamlet. And everywhere he went he met secretly with the district chief of all his spies in that area. When Stieber returned to Berlin he was carrying three trunks crammed to the lid with information.



Bismarck studied it and announced that he was ready to go into action. He provoked the French into declaring war on Prussia, and on July 15, 1870, the Prussian armies began to march.

Again Bismarck's generals knew exactly where they were going, thanks to Stieber's work. They knew the location of each fortified area, how many guns it contained, how many soldiers were stationed there, how much ammunition was on hand.

They knew the wealth of each village, down to the last chicken in a farmer's barnyard. So they wasted no time learning which houses should be taken over for quartering officers or which farmers could be counted on to supply the food they needed.

Stieber was with the army to make sure that everything went smoothly. Any French farmer who tried to keep his grain for himself when the German army demanded it was beaten or hanged—and sometimes beaten first and hanged afterward. Any Frenchman who showed curiosity about the German army—who tried to get near a head-quarters post or an installation—was hanged without a hearing.

Bismarck conquered France just as he had intended to. She was the strongest nation in Europe at that time, but he defeated her in seven months. No longer did France have the power to halt Bismarck's plans of empire building.

The conquerors were proud and arrogant, and Stieber was the proudest and most arrogant of all. Bismarck showered him with new honors and new decorations, and Stieber accepted them all as no more than his due.

But when it was a question of his work, he could be

humble if it was necessary. He would trust no one but himself to spy on Jules Favre, the Frenchman appointed to work out the peace treaty with Bismarck. And so Stieber became Favre's valet. He packed and unpacked the Frenchman's luggage, laid out his clothes, and drew his bath. Favre was pleased with the excellent service he was receiving. It never occurred to him that his valet knew all his secrets—and that Bismarck therefore knew them too.

On January 18, 1871, William, once ruler of only the small kingdom of Prussia, was crowned Emperor of Germany. It was a proud moment for Bismarck. It was a proud moment for Stieber too. He knew that much of the new emperor's glory had been achieved through his skillful spying.

But Stieber's work in France was not yet finished. Bismarck feared that the French desire for revenge against Germany might lead to another war, and he wanted to know everything that went on in France. Once more Stieber set up a network of spies there.

He sent hundreds of Germans into France, as he had done in the past. A great many of them were hotel-keepers, and many more were railroad workers. Stieber knew that the guests at a fashionable hotel were often excellent sources of information. He also knew how much could be learned by watching a country's railway system. Almost nothing of importance could happen in France at that time without Stieber being instantly informed of it.

His workers were also prepared to destroy the French railway system at almost a moment's notice if another war broke out.

It began to seem that Stieber could never fail at any-

thing he set out to do. But in his long career he did have one defeat. He met one man who outwitted him.

The man's name was Henri Georges Stephan Adolphe Opper de Blowitz, and he was a newspaper reporter. He served as foreign correspondent for the famous and powerful London "Times."

Blowitz came to Berlin to cover the sessions of a big international meeting which was held there in 1878—a meeting called the Berlin Congress. Bismarck was the president of the Congress, and every big nation in Europe had sent diplomats to attend it. Bismarck hoped to persuade them all to rearrange the map of Europe to Germany's satisfaction without regard for the rights of small nations.

Bismarck knew that some of the decisions that would be reached by the Congress would not be very popular, and so he planned to keep all the meetings secret. When the Congress was over, the world would be allowed to hear what had happened there. But while it was going on, no one except the diplomats themselves would know. Bismarck swore them all to secrecy. To make sure that no one disobeyed him, he put Stieber and his spies on the job.

"Don't worry, Excellency," Stieber told the Chancellor. "I will see to it that no one learns what goes on behind the closed doors of the Congress."

Stieber assigned spies to each diplomat who arrived in Berlin. He ordered the spies to report to him daily to tell him everything the diplomats did. And he assigned other spies to watch the newspapermen who had come to Berlin, to make sure that none of them received any information about what went on at the Congress. But almost as soon as the Congress officially opened, Stieber had a great shock. He learned that the London "Times" had that morning printed a full account of all the secret meetings that had taken place the day before.

He knew immediately, of course, who had written the story. He knew that the reporter for the "Times" was Blowitz. What Stieber couldn't understand was how Blowitz had obtained his information—right under the nose of Stieber's spies and Stieber himself.

Stieber called in his best men. "Follow Blowitz every second of the day and night," he ordered. "I want a list of everyone he talks to—or even looks at. Someone must be giving him information. I want that person's name."

From that moment on Blowitz was watched constantly. Stieber's spies reported everything he did. But it all appeared to be quite harmless. Blowitz seemed to do the very same things that all the other reporters in Berlin did. He interviewed the important diplomats, as they all did, but he never received anything but the harmless information given to all the rest.

And yet each morning the "Times" reported everything that had happened the day before behind the carefully guarded doors of the Congress.

Bismarck, of course, was furious. And Stieber's rage rose almost to the bursting point. He doubled the number of spies assigned to Blowitz. And still the stories appeared. Day after day the "Times" revealed the "secrets" of the secret meetings.

Stieber raged helplessly. He thought he was the cleverest spy in the world. Yet Blowitz was calmly beating him at his own game.

Finally, the diplomats finished their work. They all

gathered to sign the finished agreement—the secret treaty which Bismarck had been hoping for.

Stieber's spies watched Blowitz very carefully that day. The reporter did nothing new. He talked to a few diplomats, but the diplomats told him nothing of importance. Blowitz ate at his usual restaurant. And that night, since the Congress was now over, he left Berlin.

The next day the "secret treaty" appeared, in full, in the London "Times."

Stieber had failed-and he never knew why.

Actually the trick that Blowitz used was very simple, but it depended on long and careful planning.

Blowitz learned beforehand that the Congress would operate in secret and knew that the only way he could get information about it was from the inside. So he arranged to have a friend of his appointed to a minor position under one of the diplomats. The position itself was very unimportant, but it did give Blowitz's friend the opportunity to hear all that went on.

Then Blowitz bought two hats, exactly alike. He gave one to his friend and kept one for himself. Fortunately the two men wore the same size.

When the Congress opened, the friend made notes each evening of all that had happened that day. He put the notes inside his hat and set out for a certain restaurant to have his dinner.

Blowitz always ate at that same restaurant. The two men never spoke to each other. They never even met face to face. But their two hats always hung near each other on the same rack.

When Blowitz left the restaurant, he took his friend's

hat instead of his own—and with it all the facts he needed to write his story for the "Times."

The following day the hats were exchanged again. Probably Stieber would have been more angry than ever if he had known how easily and how simply he had been tricked.

Stieber's failure over Blowitz was the only major one in his whole career. And yet, with all his success and all his power, Stieber was practically an outcast in Berlin. He had no friends. The best of Prussia's society absolutely refused to accept him.

Since the early days when Stieber had first begun to betray everyone around him, except the King and the King's chancellor, the stiff-necked Prussian aristocrats had hated him. They were glad when he left the country and angry when he returned. They refused to invite him to their homes. They refused to have anything to do with him. The treated him as though he were beneath their notice.

Stieber was determined that they should accept him as an equal. Like Shulmeister, he came from a humble family. And like Shulmeister he longed to hobnob with royalty and be entertained in the finest houses.

Finally, Stieber decided to use his own methods to obtain what he most wanted. He set many of his agents to work spying on the great families of Prussia. He dug out all sorts of shameful, carefully hidden secrets—secrets which the aristocrats themselves had believed safely buried in the past. Then he put these secrets to work.

One by one he told the aristocrats what he had learned about their families. And he threatened to tell the whole world those same secrets, unless he received invitations to aristocratic homes.

His victims despised Stieber more than ever when he issued his threats, but they had to yield to him. They began to invite the hated spy to their homes, to their dinners, to their most lavish balls. And when Stieber invited them to his own parties, they accepted.

Stieber died in 1892, at the age of seventy-four. By then he had been received as a guest in almost every fine home in Berlin. He had entertained most of the Prussian aristocrats who had once refused to speak to him. He had gained great wealth and many honors. Bismarck himself called him admiringly "my king of sleuth hounds." And even today Stieber's brilliant methods are still studied by the world's espionage chiefs.

As a spy, Stieber was one of the greatest the world had ever known. As a man he was a treacherous sneak and a bully. He was feared and hated. He was despised during his lifetime, and even now his memory is despised.

King Frederick and Emperor William and Chancellor Bismarck were perhaps the only three men who ever liked Stieber. Almost certainly they were the only three men he never betrayed.





Chapter 8: THE LEGEND OF MATA HARI

THE year was 1913—or perhaps early 1914. The First World War had not yet started, but the ominous rumblings of that vast conflict were already beginning to be heard throughout Europe.

On a luxury express traveling toward Berlin one day a certain compartment had a single occupant—a handsome young Russian aristocrat named Lvov-Melikof. He was glad to be alone. It made him feel safer about the important papers in his portfolio that he was carrying from Russia to the Russian ambassador in France.

The young man had been a captain in the Tsar's Imperial Guards. He felt certain he could take care of himself and of the precious contents of his portfolio in any emergency that might arise. Nevertheless, when the train stopped at Posen, he was angered for a moment to

see that he was going to have a companion for the rest of the journey. A woman was opening the door from the outer corridor and looking toward the empty seat opposite him.

But before she could cross the threshold, a man in the uniform of a train conductor stopped her with a curt inquiry. She answered in a low polite voice. The man addressed her a second time, even more curtly.

The young Russian could see that something was wrong. He thought perhaps the woman's ticket was not quite in order. He reminded himself that her troubles were not his business, but he couldn't help but feel sorry for her. The argument was growing more heated. The conductor was scowling rudely and raising his voice.

Finally Lvov-Melikof could stand it no longer.

"Madame, I hope you will forgive me for interfering," he said, getting to his feet. His French was as correct as the bow he made her. "But is there anything I could do to assist you?"

She looked gratefully at him. "Monsieur," she murmured. "You are very kind. It is a trivial matter, but I can't seem to explain to *le conducteur* that my ticket here . . . ." She held the bit of pasteboard out to her rescuer with a trusting gesture.

Lvov-Melikof didn't even bother to look at it. With the lordly manner he had learned in the Imperial Guards he turned on the conductor. The uniformed man backed hastily away, his arrogance crumbling. A moment later he was gone, muttering apologies over his shoulder.

"Oh, Monsieur, how can I ever thank you?" the woman began.

"Please—I beg of you. It was of no consequence."

Lvov-Melikof saw her clearly for the first time as she settled herself in the carriage. Her jewels and furs were expensive. She carried her tall graceful body with an aristocratic air. And her great dark eyes were the most beautiful he had ever seen.

"I am only glad that I was here at the moment," Lvov-Melikof went on. "The man was impudent. The rail officials should dismiss him."

"He was indeed impudent." The beautiful eyes were smiling now. "But I'm afraid I can't agree with you that what you did was of no consequence. He was actually trying to put me off the train—and my husband would be dreadfully worried if I did not arrive in Berlin today."

Suddenly she leaned forward. "Monsieur, if you too are going to Berlin, do at least let me offer you hospitality in return for your help. Won't you have dinner with us this evening? I know that my husband, the Count von Linden, will also want to thank you, to tell you how grateful he is for your chivalry."

"Madame, I am truly sorry," Lvov-Melikof answered. "But I shall be in Berlin only a brief time. I am just passing through on my way to Paris."

"Oh, what a pityl Then we can't entertain you. I am so disappointed!" the woman said.

They talked together for the rest of the journey to Berlin. By the time they reached the city, Lvov-Melikof realized that he too was very disappointed not to be able to accept the woman's invitation. He thought she was the most beautiful and enchanting woman he had ever met, and he would have been very pleased to spend the evening with her.

Instead, he had to say good-by and wait in the station for his train to Paris.

But soon after the woman left him, he discovered that his train was not running on schedule. He hurried to a telephone and called the Countess's home.

"My train will be late leaving Berlin," he said. "I shall be here for the evening."

"How delightful!" she exclaimed. "Then you can have dinner with us after all."

That evening Lvov-Melikof took a taxi to the address the Countess had given him, on the Dorotheen Strasse. He glanced up at the house when he arrived. It was large and luxurious, just as he had expected it to be. He mounted the broad steps and rang the bell. A butler admitted him.

The Countess came forward to greet him with a telegram in her hand. She looked very unhappy.

"Something dreadful has happened," she said. "This telegram came just a few minutes ago—a message calling my husband out of town. A relative of his is very ill, and of course the Count had to go. He left immediately. So he is not here to welcome you and to thank you. We are both so sorry."

Lvov-Melikof tried to pretend that he was sorry too. Actually he was very glad to think that he would have the charming Countess all to himself for the evening.

"I shall do my best to be cordial enough for two," the Countess told him. "Come—there are drinks waiting for us in the drawing room. You must forgive my husband for not being with us, and share them with me."

Lvov-Melikof enjoyed the evening even more than he had thought he would. The Countess was gay and enter-

taining. Her food was excellent. So was the wine. And the Countess had also provided vodka from her guest's homeland. Her butler kept Lvov-Melikof's glass constantly filled to the brim.

The young Russian drank a great deal, but he knew he was in no danger of losing his wits. As a captain in the Guards he had been able to compete with every man in his company, glass for glass, and still keep a steady eye and a clear head.

Gallantly he raised his vodka in a toast to the Countess's beautiful eyes.

The next thing he knew he was waking up on a strange bed, in a strange room. For a moment he had no idea where he was. Then he recognized the Countess's butler, bending over him.

"Does Monsieur feel better now?" the butler asked. Lvov-Melikof touched his throbbing head and tried to sit up. "I'm all right, I think. But what happened?"

"Monsieur, I regret to tell you." The butler looked very sorry. "Monsieur fell asleep at table. It was my fault, no doubt. I should have realized that Monsieur had a poor head for wine."

"A poor head? Nonsense. But it was not your fault, of course. It was mine. It must have been. And yet I can't understand it. To drink so much that I fell asleep—such a thing has never happened to me before."

Lvov-Melikof felt very confused. He was also ashamed and embarrassed.

"My behavior was inexcusable," he said, getting stiffly to his feet. "The Countess will never wish to see me again, naturally. She could never forgive such rudeness."

Suddenly, at that moment, the young man had a fright-

ening thought. He remembered the important papers in his portfolio. Were they safe? He had promised, before he left Russia, that he would never let them out of his sight until he delivered them safely in Paris. And now he had left them unguarded for several hours.

He opened the portfolio with trembling hands—and sighed with relief. The papers were there, safe and sound. And his fountain pen with its secret compartment—that too was in the same pocket where he had left it.

Lvov-Melikof was very relieved. But he was also very angry with himself as he left the house on the Dorotheen Strasse in the cold light of that early dawn. He felt he had insulted the Countess by drinking so much at her table that he had fallen asleep. And he had also, though this she must never know, insulted her again by suspecting, even for a moment, that someone in her household might have stolen his papers while he was asleep.

He caught the next train for Paris and he never saw the Countess again. But shortly after he returned to Russia he was arrested. A vital piece of information had leaked out—a piece of information which had been mentioned in the papers he had carried to Paris. No one accused Lvov-Melikof of treachery. But he was accused of carelessness, and that was almost as great a crime under the circumstances.

Young Lvov-Melikof, like many men before and after him, had fallen victim to the charms of the woman who sometimes called herself the Countess von Linden.

She was not a countess. She had no husband. Her quarrel with the uniformed man on the Berlin express train had been a carefully rehearsed scene. The "conductor" who played it with her was in reality a secret

service agent. Their argument had been for Lvov-Melikof's benefit, designed to win his sympathy for a lady in distress. And the train to Paris had been held up by special order, so that the young Russian would be free to accept her invitation.

It was not the wine that had made Lvov-Melikof fall asleep. It was the dope that had been poured into his drink. The helpful "butler" was not a butler. He too was a secret agent.

And still other agents had been on hand to examine the young man's papers while he lay unconscious. One, skilled at lock-picking, had opened the portfolio. Other men had photographed the documents and then returned them to their places. They had even found the tightly rolled tube of rice paper hidden in the secret compartment of the fountain pen.

It cannot be said for certain that the story of Lvov-Melikof's betrayal is true. Perhaps it is only one of the legends that have grown up around the woman who told the young Russian that she was a countess.

There are many legends about her, and in them all she appears as one of the greatest spies of all time. Her real name was Margarida Gertrud Zelle-MacLeod. But she will always be best known by another name—Mata Hari.

If the story of Lvov-Melikof is true, then the young Russian was more fortunate than many of Mata Hari's victims in at least one respect. She only cost him his freedom. She did not also cost him whatever fortune he possessed.

Mata Hari was greedy for money. She persuaded most of her admirers to give her huge sums of it. And if they failed to give her the presents she expected, they found that they were not permitted to see her again. Probably the only reason Mata Hari ever did any spying was that she thought it would pay her very well.

No one knows exactly how much money Mata Hari earned as a spy. And no one knows exactly how much spying she did. It does seem to be true—so far as the truth can be known—that she wasn't very clever at it. Nevertheless, she became famous as a secret service agent even during her lifetime. And today, when hundreds of more skillful spies have written their stories across the pages of history, she is somehow still thought of as one of the greatest of them all.

Certain facts are definitely known about her. In their own way they are as strange and curious as any of the legends that cluster around the mysterious name of Mata Hari.

Margarida Gertrud Zelle, born in Holland in 1876, was the daughter of a Dutch burgher and his Dutch wife. Her childhood was normal and peaceful, and at the age of fourteen she went to a convent school for four years. She was eighteen, and just out of school, when she met a man named Campbell MacLeod.

MacLeod was already middle-aged and serving as a captain in the Dutch army on duty in Holland's colonial possessions. He drank heavily and seems to have been a brutal and worthless man. But the young Dutch schoolgirl married him and went with him on his next assignment to Java.

Six years later young Mrs. MacLeod returned to Holland with a baby daughter. Her husband had beaten her and mistreated her. Her married life had been a torture.

She had left him and was determined to get a divorce. Her respectable relatives were shocked at the idea. They tried to persuade her to return to her husband. But Mrs. MacLeod refused, and finally she won her freedom.

Four years after her return from Java, Margarida made her first public appearance as a dancer. She called herself Mata Hari, a Javanese name meaning "Eye of the Morning."

From that moment on Margarida's nationality, her parents, her child, and her husband all faded into the past. As Mata Hari she claimed she was half-Javanese—an oriental dancer trained in the secret temples of Java. Now, she said, she was offering the long-secret temple dances to a European audience for the first time.

Her performance was exotic and striking. Her strange name, the mysterious background she had built for herself, the beauty of her eyes and her figure, made her an immediate success. Almost overnight she became one of the most sought-after women in Europe. Soon her admirers included the Crown Prince of Germany, the Duke of Brunswick, a Dutch premier, and many other wealthy and influential men.

All of them gave her the expensive presents and the gifts of money that pleased her so much. And all of them told her important political and military secrets. Apparently Mata Hari soon discovered that she could sell those secrets and obtain even more money.

It is known now that the German secret service organization made use of her talent for coaxing secrets out of the men she knew. Mata Hari herself never admitted that. But even in the very earliest days of the First World War the intelligence experts of France and Britain suspected it. Their agents began to follow her.

Wherever she appeared as a dancer, there were agents in the audience. Whenever she moved from one city to another, with her trunks, her servants, and her devoted admirers, there were agents on the train. They were particularly interested in the German generals and the known German spies who visited Mata Hari. Usually she met them in the neutral countries where so much espionage went on during the war.

Finally both French and English officials questioned her. They charged her with being a spy for Germany.

"I am not," she declared. "I have no concern with this war. I am a neutral. It is true that members of the German secret service have given me money, but they were not paying me for spying. They were simply giving me presents—as so many of my admirers do."

The officials didn't believe her.

"You say you are a neutral," they pointed out. "But you have lived in Germany. Don't you want Germany to win the war?"

She looked at them out of her beautiful eyes. "Oh, no," she said. "My sympathies are with you—with the Allied nations who are fighting against Germany. I will prove it to you. I will spy for you against Germany."

The Allies accepted her offer—or at any rate they pretended to. They gave her the names of certain Allied agents in Germany. A few days later one of those agents was arrested by the German police. It seemed clear that Mata Hari had betrayed him to her friends in the German intelligence.

Finally those friends began to mistrust her too. Apparently everyone who knew Mata Hari decided after a time

that whenever she discovered a secret she offered it for sale to the highest bidder. But her admirers were so powerful and so important that the secret service officers were afraid to arrest her. They knew that she could call upon royalty and government officials to protect her.

They had to lay a trap in order to catch her. A German military officer in Spain sent Mata Hari a message by coded wireless. It ordered her to go to Paris where she would receive payment for certain espionage activities she had just performed in Spain. Mata Hari obeyed. She was, as usual, eager for money. When she arrived in Paris she was met by the French authorities.

The Germans had decided to let their enemies be responsible for her. The code in which the wireless message had been sent was one that the French had already broken, and the Germans knew it. French intelligence agents had quickly interpreted the message and were waiting for the dancer when she arrived. They jailed her immediately to await a court-martial..

Her trial was swift. The French court appointed a lawyer to defend her, and apparently he believed that his client was innocent. No one else agreed with him. The court decided that Mata Hari was guilty. It sentenced her to be shot.

One of the legends about her declares that a young man who loved her tried to bribe the firing squad which Mata Hari was to face at dawn on October 15, 1917. He believed his offers of bribery had been accepted, and assured Mata Hari that the guns which would be aimed at her would contain only blank shells. Afterward, he promised, she would be rescued from the prison and taken to safety.

But those who saw Mata Hari on that last grim morning of her life do not believe the legend. They say she did not look like a woman who expected to be rescued from death at the last moment. They say she was calm and brave, but that she no longer had any hope. She seemed to know that her fabulous career was at an end, and that none of her important friends could save her.

In a letter to her daughter, then seventeen years old and living in Batavia with relatives, she wrote:

My dear child:

There is much I would like to tell you and so little I can say. My time is getting short. Fading out. It is four in the morning and within an hour or so, I will be among the dead without ever having had the chance of seeing you again. You were a baby when I left you. Believe me, I did nothing that was wrong, but war has its own brutal laws. I do not believe in mercy for me, not even political friends can help me this time.

The letter ended, "Goodbye, my child, find your happiness in life and find it without hating me." And it was signed, "Your mother, Margarida Gertrud Zelle-MacLeod."

A few minutes after she finished writing her letter, a guard arrived to escort her to the prison courtyard. A nun who was with her at the time collapsed into tears, and perhaps it was Mrs. MacLeod who comforted the woman, gently shaking her until she was quiet again.

But it was Mata Hari, the dramatic and adored toast of a continent, who stood proudly erect before the firing squad a few minutes later. She refused to have her eyes bandaged. She stood perfectly still, with a dancer's grace, as the soldiers lined up before her.

Mata Hari was probably not a good spy. Some who saw her say she was not even beautiful. Some say her dancing was as falsely oriental as the name she used. She seemed to have no patriotism to any land and no loyalties of any kind. She was apparently willing to sell herself and all she knew for whatever price the market would bring.

But her bravery in those last moments cannot be questioned. And perhaps she deserves to be remembered—not as a spy, but as a young Dutch girl who transformed herself into one of the most famous women of all time.

The final order cracked the early dawn silence.

"Fire!"

Twelve guns responded.

And Mata Hari, the legendary figure in a thousand tales of intrigue and espionage, slumped lifeless to the bare ground.

But the legends still live. She had stirred the imaginations of many men. And as Mata Hari, the "Eye of the Morning," she will doubtless continue to stir imaginations as long as stories are told anywhere in the world.



Chapter 9: THE MYSTERIOUS CICERO

Ludwig Moyzisch, German intelligence officer in Ankara, Turkey, was a very worried man.

It was October of 1943. Germany's enemies in the Second World War—the United States, Russia, England, and the other Allied Nations—were winning more battles every day. Once Germany had been sure she could conquer them. Now she was not so certain. It seemed possible that Germany might lose the war.

It also seemed possible that Moyzisch might lose his job. His bosses, back home in Berlin, were not satisfied with the information he was sending them.

"You are stationed in a neutral country," they told him, "with excellent opportunities for espionage. All our enemies have embassies there. Why have you not been able to learn what is going on in those embassies? England

and the United States are openly planning to invade Europe, and we need to know the date of their invasion. They are also trying to persuade Turkey to join the war on their side, and we must know what Turkey intends to do. If you cannot obtain such information for us, you will be dismissed from your post and sent to fight on the Eastern front."

Moyzisch was doing the best he could. But the Allies knew that Turkey—like any neutral country during a time of war—was swarming with spies. They had spies of their own there. And they guarded their secrets well from anyone they suspected of being a German agent. Moyzisch had not been able to learn very much about the Allies' plans.

"Sure-but how?" his friend asked.

Then one day two new boys moved to Aalborg from the Danish town of Odense. Their names were Knud and Jens Pedersen, and they too became students at the Cathedral School.

"In Odense," Knud told his new friends, "we had a club to fight the Germans. We called it the Royal Air Force Club."

Chapter 11: KLAUS FUCHS AND THE ATOM BOMB SPIES

On a certain cold winter afternoon, early in 1944, a tall, earnest-looking young man stood on a New York City street corner with a tennis ball in his hand. He must have looked rather strange, considering the weather. Certainly he was playing a part in one of the most dramatic stories to come out of World War II and the years that followed.

For some time he waited, watching the crowd streaming past him. Then suddenly he saw what he was searching for—a man carrying a green book, wearing one pair of gloves and holding another pair in his hand. The book and the two pairs of gloves were the signals by which the young man had been told he could recognize the man he was seeking. The tennis ball in his own hand served as his badge of identification.

The tall young man stepped forward. The two men

spoke to each other. They got into a taxi and drove to a certain restaurant. There the man with the tennis ball gave the other man a package of papers.

Those papers held part of the vital secret of the atom bomb.

The man who received the papers was a spy for Soviet Russia. The man who betrayed the secrets of the atom bomb—at that meeting and others before and afterward—was a brilliant scientist named Klaus Fuchs.

The story of Klaus Fuchs begins in Germany, where he was born in 1911. His father, Dr. Emil Fuchs, had been a Lutheran minister who left that church to become a Quaker. There were four children in the family. They were all intelligent and all had inherited their father's high ideals. They were all very much disturbed when Adolf Hitler and his brown-shirted Nazi followers began to grow powerful in Germany. Even Klaus, the youngest, sometimes deserted his beloved school books to join the family discussions on the subject.

Finally one day Klaus said, "Hitler is a menace to Germany and to the whole world. We must fight against him."

Dr. Fuchs shook his head. "My son," he said, "it is true that Hitler is dangerous. But you are a peace-loving Quaker, like myself. You know that if we tried to destroy Hitler by fighting against him, we would only destroy ourselves. It is always wrong to fight."

In the past Klaus had hated fighting as much as his father did. He had followed Dr. Fuchs not only into the Quaker church, but also into the Social Democratic party—a party which stood firmly against Hitler but which hoped to defeat him by ballots rather than by bullets.

Now Klaus was not so sure that Quaker pacifism and the peaceful program of the Social Democrats was enough. Like many of his fellow students at the University of Leipzig, he began to take an interest in the German Communist Party. After a time he decided that the Communists were the only ones who understood how dangerous Hitler really was.

"They understand that it's necessary to destroy Hitler and Nazism now and forever," he told his father. "I'm willing to fight with them, to protect Germany and the freedom of all Germans."

Klaus had always been a good student. His specialty was science and he showed promise of becoming a brilliant physicist. But in his eagerness to defeat Hitler he even deserted his books to attend Communist meetings and distribute propaganda leaflets.

Hitler, however, proved too strong for all his opponents, including the Communists. In 1933 he became chancellor of Germany—and immediately all those who had opposed him stood in danger of losing their lives.

Even the gentle Dr. Fuchs was thrown into jail. One of Klaus's brothers escaped to Switzerland. One sister fled to the United States. Another sister, whose husband was being pursued by Hitler's dreaded police, the Gestapo, threw herself from a train and was killed. Klaus himself went into hiding for several months, until he could escape to England. There he found a home with Quaker friends.

At first he couldn't think of anything except how wonderful it was to be safely out of Germany. He paid very little attention to politics. The hospitable British soon discovered how brilliant this young refugee was, and they arranged for him to continue his studies at Bristol University. Klaus buried himself in his work.

By 1939 he had earned two doctorate degrees, in mathematical physics and theoretical physics, and won a scholarship to continue his research at the University of Edinburgh. That same year—he was about 27 years old—he applied for citizenship in England.

But in 1939 England went to war against Hitler. All Germans living in England at the time were automatically listed as enemy aliens. Klaus Fuchs's request for citizenship was refused.

Nevertheless, because of his excellent record, Fuchs was allowed to continue his work—until the time came when England expected an invasion by Hitler's forces. Then she felt she had to take new precautions. She could no longer allow any Germans, however loyal to England they seemed, to remain on British soil. Some of them might be spies, ready to give aid to the expected invaders. And so England sent hundreds of German refugees to a camp in Canada. Klaus Fuchs was among them.

An unfortunate accident occurred during all the confusion of the journey across the Atlantic. The identification papers of Klaus Fuchs and the other members of his group were lost.

"These men arrived without papers," a British officer told the camp commander when the group arrived. "We don't know who they are."

"No papers?" The commander looked thoughtful. "If they were registered enemy aliens their papers would have been sent along with them. If they have no papers it means they have never been registered. They must be Nazis who dropped into England by parachute. We'd better confine them with the other men who admit they are loyal followers of Hitler, and guard them accordingly."

Fuchs and the other members of his group tried to explain the facts, but the evidence was against them. They were officially labeled as Nazis. And Klaus Fuchs, who hated Hitler, had to live for months with the sort of men who had jailed his father, hounded his sister to her death, and forced the rest of the Fuchs family to flee.

Probably those months in the Canadian camp were a turning point in the young scientist's life. During all his years in England he had avoided the Communists. Now, apparently, he decided once again that only the Communists knew how to fight Hitler—that only the Communists drew a clear line between those who hated the Nazis and those who admired them.

Finally, in 1941, English scientists who knew Klaus Fuchs and trusted him obtained his release from the camp. Fuchs returned to England.

To his friends and fellow-scientists he seemed the same man he had been before—quiet, hard-working and rather shy. They didn't guess that Klaus Fuchs had made up his mind to turn over to Russia, from then on, any scientific secrets he thought might be useful to the Communists.

Russia was by then in the war. Like England, she was fighting for her life against the Germans. She was an ally of England, and when the United States entered the war Russia would be her ally too. But she was not a friendly ally. Already many Englishmen and Americans were saying that their countries could get along with Russia only so long as they all had a common enemy.

Even the British secret service agents, however, didn't

suspect that Klaus Fuchs was now determined to serve Soviet Russia to the best of his ability. They studied the young man's record and found no reason why he shouldn't be trusted with highly secret documents. Soon Fuchs was doing important scientific research for the British government. When he again requested British citizenship, his request was granted—although very few enemy aliens received this high proof of English trust during the war.

Klaus Fuchs swore an oath of allegiance to England, and an oath never to reveal the secrets of the important work entrusted to him. But he didn't keep those oaths. He began to meet with Russian spies, or agents—on street corners, in small out-of-the-way restaurants—and turn over to them all his own vital work. Soon his reports included the work of other scientists too.

In the meantime Fuchs was becoming steadily more important among England's scientists. And those scientists were playing a steadily more important part in the war. They were laying the groundwork for what would one day be the most devastating weapon the world had ever known—the atom bomb.

By the time the United States entered the war, American scientists too were working along the same lines. When England and America learned that Germany too was trying to make an atom bomb, the two Allies decided to pool their work and cooperate from then on. They were determined to beat the Germans in this deadly race.

Top-flight British scientists came to the United States to work with top-flight American scientists. One of the men in the group that crossed the Atlantic was Klaus Fuchs. He spent some time in laboratories on the East Coast, and then went to the carefully guarded atomic research center at Los Alamos, New Mexico. There, at long last, the first atom bomb was completed. Fuchs was among the handful of trusted scientists who watched the explosion of that bomb in the New Mexican desert on July 16, 1945. Germany, unable to make an atom bomb herself, had already surrendered to the Allies two months before.

Three weeks later, in August, 1945, American planes dropped atom bombs on the Japanese cities of Hiroshima and Nagasaki, and Japan too surrendered. World War II was over.

Klaus Fuchs returned to England to head an important department in the big new atomic energy laboratory established at Harwell.

His friends were proud of him. They believed he had helped to bring peace to the world. But Fuchs was not sure that that peace would last. As he watched unfriend-liness grow between Russia and her former allies, he continued to report to Russia new developments in the field of atomic energy.

Many Britons and Americans also feared that the new peace would give way to another war—a war with Russia. But they thought that so long as the United States had many atom bombs, and Russia had none, the Russians would not dare to begin such a war. England and the United States were therefore shocked to discover, in 1949, that Soviet Russia too had learned how to make atom bombs—that an experimental bomb explosion had already taken place there.

How had Russia learned so quickly all the intricate secrets of the atom bomb? Experts agreed that there could be only one answer to that question: One or more of the scientists who worked on the first American bombs must have given or sold those secrets to her.

Immediately the secret service agencies of England and the United States began an investigation. Once more they checked all the scientists who had worked at Los Alamos and the other atomic laboratories. And slowly, bit by bit, their investigations brought them to Klaus Fuchs.

"Yes," Klaus Fuchs said, when they finally came to question him. "I did give atom bomb secrets to Russian agents. I believed the Communist way of life was the best way, and the best protection against Nazism. I wanted to help the Communists as much as I could.

"But," he added, "I have changed my mind. I no longer think that Russia is the idealistic country I once thought it was. For a year I have given the Russians nothing. And I am deeply sorry for what I did in the past."

He confessed everything. He told all the details in the story of his meetings with Russian agents—how he had identified himself once by carrying a tennis ball, and another time by carrying two books in one hand and a package of five books, tied with string, in the other.

His own testimony was all that was needed to convict him. His trial was brief. The verdict: guilty.


"It is impossible!" his friends said at first. "He is such a quiet man, such a hard worker and so devoted to science. We can't believe it!" But Klaus Fuchs himself convinced them with his testimony. He left no room for doubt.

The judge pronounced a sentence of fourteen years' imprisonment.

Klaus Fuchs was not the only man who gave the Rus-

sians information about the atom bomb. He is not the only one now serving a prison term for his treachery. But probably none of the others were so outstandingly brilliant as this quiet scientist who was once so trusted and admired.

Even now few of his fellow-scientists hate him. They feel only pity for the man who never made an error with his mathematical calculations, but who made such a grave error with his life.

As a volunteer spy for the Northern armies, he crossed the Confederate lines and returned with so much valuable information that he was made a brigadier general and chief of all secret service work for the North. He was one of America's greatest spies.

Louise de Bettignies, a young French governess, built up—almost singlehandedly—a remarkably efficient spy network in France during World War I. When the Germans finally caught her, they felt so much admiration for her courage and intelligence that they sentenced her to prison rather than to death.

VELVALEE DICKINSON owned an exclusive New York City doll shop during World War II. She sold only very expensive dolls, many of them antiques, and doll collectors from all over the world were her customers. As a spy for the Japanese, she used her dolls as a clever means of sending vital information out of the country. A doll's tiny necklace or the design of a doll's dress often carried a secret message betraying American ships to the enemy. But the United States Secret Service finally caught the "doll woman" traitor, and she went to prison.

Job Kattenanit, an Indian brave, was probably America's first spy. He became friendly with the early colonists in Massachusetts and joined their Christian church. When the colonists were fighting the Indians, in the long bitter conflict known as King Philip's War, Kattenanit volunteered to visit the Indian encampment and spy for the white men. The Indians suspected him and fired at him with bow and arrow. One arrow pierced his chest and he was left for dead in the snow. But Kattenanit, with the arrow still embedded in his chest, walked nearly eighty miles to Boston and arrived in time to warn the colonists of the next Indian attack.

Thomas Edward Lawrence, often called Lawrence of Arabia, was one of England's most famous soldiers of fortune. He was also a great spy. Before the beginning of the First World War he lived for many years in Arabia, which was then ruled by Turkey. He learned so much about Arabian customs and language that he was often mistaken for an Arab himself. When the war began, he formed an Arab Legion, equipped it with arms sent to him by England, and led many attacks against Turkey, which was an ally of Germany and thus England's enemy. Sweeping down out of the desert like a whirlwind, Lawrence and his Arabs wrecked Turkish trains and bridges and captured many Turkish towns. Also, skillfully disguised as a native, he made many spying trips through the Turkish lines to obtain information of

vital importance to England. He helped England defeat Turkey, and, in addition, he freed Arabia from Turkish rule.

ALFRED REDL, in the year 1900, was the brilliant head of Austria-Hungary's secret service. He was so clever that his country's enemy, Russia, knew she couldn't outwit him. Instead Russia offered Redl great sums of money if he would betray his country. Redl, as greedy as he was brilliant, agreed. For many years he turned over to Russia all Austria-Hungary's most important secrets, including her plans to invade Serbia, a Russian ally. He even betrayed his own spies to the Russians. Just before World War I broke out, the Austrians discovered that Redl was a traitor. They gave him a gun and permitted him to shoot himself, rather than trying him publicly for treason.

ELSBETH SCHRAGMÜLLER, better known as "Fraülein Doktor," was probably Germany's greatest woman secret agent during World War I. As director of a school for spies, she trained many German agents who were later sent on spying missions into England, France, and other Allied countries. She is said to have been so ruthless that she would deliberately betray her own spies to the enemy when she thought they were no longer useful to her.

WILLIAM SEABOLD, a German-born American citizen, was visiting his native country in 1939 when the German secret service approached him and asked him to spy for Germany in the United States. At first Seabold refused. But when the Germans told him that his German relatives would be made to suffer if he disagreed, he pretended to fall in with their plans. Actually he immediately informed the American Consul of what he was doing and asked that the information be given to the

F.B.I. After attending a German spy school, to learn photography and radio, he returned to the United States and set up a short-wave station for transmitting intelligence messages to Germany. He kept the F.B.I. informed of everything he was doing—the F.B.I. even helped him set up his transmitter. Through Seabold the F.B.I. knew almost every message that went to Germany for the next several years and also learned the identity and activities of the German spies in the United States. Seabold's information helped American G-men round up the Nazi spies and saboteurs sent to the United States by Germany all during World War II.

Carl Wassmuss, a young German, plagued the English in British-controlled Iran during World War I, just as Lawrence was plaguing the Turks in Arabia. He too formed a band of native warriors and equipped them with arms sent from Germany. He was so successful that England had to keep a large force of men in Iran (then called Persia), to guard her oil wells and lines of communication, and she also had to maintain several warships off the coast. Wassmuss made clever use of native fishing boats to spy out British naval and military movements. Finally England offered a reward of 30,000 pounds—about \$150,000 in those days—for the capture of Wassmuss, dead or alive. But the reward was never claimed. Wassmuss escaped, and when the war was over he vanished completely.
