STADIUM & FACILITIES

SEATGEEK STADIUM - BRIDGEVIEW, ILLINOIS

SeatGeek Stadium is the heart of soccer for much of the Midwest and a must-see destination for worldclass concerts and other sporting events. Each year, more than a half million people go by the stadium's trademark brick arch, many achieving or reliving what has become a rite of passage for sports and music fans alike.

Tailgating opens (3) three hours prior to kickoff and is permitted in all parking lots.





Rory Dames will be entering his seventh season at the helm of the Red Stars, after leading them to two league finals and a USASA's National Women's Cup triumph in 2012. Last year, Dames became the fourth coach in National Women's Soccer League (NWSL) history to reach 50 wins and only the second coach to do so with one team.

Dames also serves as the Director of Coaching and Player Development for Chicago's Eclipse Select Soccer Club, which consisted of three teams when the Illinois native took over in 1996 and today boasts over 50 male and female teams with more than 750 players ranging from ages 8-19.

Dames has led Eclipse Select to many accomplishments over the past ten years, including being recognized as the top girls soccer club in the nation by Soccer America in 2007 and 2008, as well as by NationalSoccerRanking.com in 2007. Over the years, Dames has lead the club to eight national championships, six national finals, eleven regional championships, 17 UYSA MRL championships and 37 Illinois State Cup championships.

Born and raised in Chicagoland, the Red Stars Head Coach played his high school soccer at St. Viator in Arlington Heights until graduating in 1991. Next, he went on to star for St. Louis University, winning several conference championships and making an appearance in the NCAA Final Four. Dames then joined the Rockford Raptors for one professional season. After his college career, Dames went on to coach not only Eclipse Select but also his high school alma mater. He would serve as Varsity Girls Head Coach at St. Viator for eight seasons (1997-2005) and guide his teams to seven conference championships and seven regional titles. Dames made five trips to the Elite Eight during his tenure at St. Viator, winning three state championships.

The man in charge of the Red Stars continues his work at the youth level, having turned Eclipse Select into one of the best known and most respected girls clubs in the nation. He also serves as the ID2 National Girls Director. Dames currently resides in Antioch, Illinois.

Roster Rules

I. ROSTER CATEGORIES

NWSL Rosters fall into two broad categories:

A. Senior Roster

The Senior Roster is comprised of Players who are eligible for any compensation, including bonuses, as allowed by NWSL policies. Salaries of Players on the Senior Roster count against the Salary Cap, except as otherwise noted.

The Senior Roster for the 2021 NWSL League Season is 22-24 Players.

B. Supplemental Roster

The Supplemental Roster is comprised of Domestic Players who sign a Semi-Guaranteed SPA for the League Minimum Salary and the only bonus they are eligible for is the League-provided Post Season Bonus. Salaries of Players on the Supplemental Roster do not count against the Salary Cap. Supplemental Roster Players must be provided year-round housing and are eligible for the same auto benefits as Senior Roster Players.

The Supplemental Roster is zero (0) to four (4) Players.

Players on the Supplemental Roster are subject to the same rules that govern Players on the Senior Roster, unless specifically noted. Except for salary, Players on the Supplemental Roster are afforded the same opportunities and other benefits as those on the Senior Roster – including being eligible for selection in all NWSL matches. The same League processes (e.g., Discovery, Waiver Wire, trades, payroll, etc.) utilized for Players on the Senior Roster shall apply to Players on the Supplemental Roster.

Teams may move Players from their Senior Roster to their Supplemental Roster if they have a slot on the Supplemental Roster available, and the Player moving to the Supplemental Roster is earning the League Minimum Salary with no performance bonus(es) other than the League-provided Post Season Bonus. Teams may also move Players from their Supplemental Roster to their Senior Roster if they have an open slot and sufficient Salary Cap space to accommodate the move. A Player may be moved between a Team's Senior and Supplemental Rosters only one (1) time between the Roster Compliance date and the Roster Freeze date of each League Season. A Player's salary stops counting against the Salary Cap on the day after she is moved from the Supplemental Roster to the Senior Roster.

Teams will not be provided with Roster relief or Salary Cap relief with respect to Supplemental Roster Players placed on the 45-Day Disabled List or on the Season-Ending Injury List.

II.COMPENSATION

A. Player Categories

NWSL Player SPAs fall into two broad categories:

- 1. Guaranteed SPA
- 2. Semi-Guaranteed SPA

With League approval, Teams may waive Players with Guaranteed SPAs prior to the Roster Freeze date in order to create Roster space. The Player's salary may count against the Team's Salary Cap, per League policy (see Buyout of Guaranteed SPA). There is no limit to the number of Guaranteed SPAs a Team may have, and all international Players and SPAs utilizing Allocation Money must be Guaranteed SPAs.

If a Player on a Semi-Guaranteed SPA is waived prior to Roster Freeze, their salary ceases to count against the Team's Salary Cap on the day after the Player is placed on the Waiver Wire.

If a Player is injured in the course of providing services to NWSL, her employment may not be terminated until she passes her exit physical or the course of the term of her SPA ends, whichever comes first (including Replacement Players).

B. Allocated Players

"Allocated Players" are Players whose salary are either paid for or subsidized by a national association, as determined by that national association.

U.S. Allocated Players' salaries are paid directly to the Player by USSF and Canadian Allocated Players' salaries are paid to the League by CSA, and the League pays the Players. Allocated Players' salaries count at a specified value against each Team's Salary Cap, or for CSA Allocated Players, the actual amount, if below the specified amount. Teams may supplement a CSA Allocated Player's salary, with any amount that is above the specified amount and less than the League Maximum Salary counting against the Team's Salary Cap (unless Allocation Money is used).

C. Salary Cap Regulations

Team Salary Cap

In computing the Team Salary Cap, it is assumed that it is spread across a minimum of 22-24 Players (if a Team is carrying additional Players because of Roster Relief or Goalkeeper Replacement, these Players are also included) based on adjustments for Allocated Players.

D. Allocation Money

Allocation Money is financial credit that:

- 1. Teams may purchase from the League, within limits defined by the League each year; or
- 2. Are acquired from another Team through a transaction; or
- 3. Are directly funded by the League and provided to a Team.

Once Allocation Money has been funded by one of the mechanisms described above, it becomes "Funded Allocation Money" (FAM).

FAM can (subject to the various rules and restrictions described herein) be redeemed by Teams to:

- 1. Pay a Player on an SPA more than the League Maximum Salary;
- 2. Reduce the Salary Cap charge of a Player's salary; or
- 3. Pay a transfer fee when acquiring a Player who is currently under contract outside the NWSL.
- FAM is a tradable asset and can be included in transactions between Teams.

FAM automatically carries over from one calendar year to the next and does not expire.

III. ROSTER LIMITS AND PLAYER CLASSIFICATION

A. Roster Limits

After the Roster Compliance date, Teams must meet the following Roster conditions:

- 1. No fewer than twenty-two (22) Players rostered at any one time between the combined Senior Roster and Supplemental Roster;
- 2. No more than twenty-four (24) Players assigned to its Senior Roster at any one time;
- 3. No more than four (4) Players assigned to its Supplemental Roster at any one time.

Players listed as "Unavailable" on a Team's Roster do not count towards Roster minimum or maximum numbers.

Roster limits are subject to Short-Term Injury Replacement, Season-Ending Injury Replacement, Goalkeeper Replacement, and National Team Replacement Player exceptions, and in exceptional circumstances, as permitted by the League.

Roster Compliance Date

A Team may exceed the maximum number of Players assigned to its Roster and the maximum number of international Roster spots starting the day following the NWSL Championship through the date specified by the League prior to the start of the next regular season (the "Roster Compliance Date"). A Team may exceed the Team Salary Cap starting on January 1 until the Roster Compliance date.

Roster Freeze

No changes (including waiving Players) may be made to a Team's Roster from the Roster Freeze date until after the NWSL Championship. Teams may add a short-term replacement Player after the Roster Freeze date in the case of a Goalkeeper Replacement Player or a National Team Replacement Player. A Player coming off the 45-day Disabled List or Season-Ending Injury List may return to competition after the Roster Freeze date.

B. Player Classifications

1. Domestic Player

There is no limit to the number of Domestic Players on a Team's Roster within general Roster limits.

2. International Player (any Player who is not a Domestic Player)

There is an equivalent of four (4) international Roster spots per Team for the 2021 League Season, for a total of forty (40) international Rosters spots League-wide. International Roster spots may be traded with the only condition being time (see Trades). With trades, there is no limit on the number of international Roster spots a Team may have. Any international Player must occupy an international Roster spot on a Team's Roster (with the exception of Canadian Allocated Players). International Players must have Guaranteed SPAs and may not be on a Team's Supplemental Roster.

IV. MECHANISMS OF ACQUIRING PLAYERS

A Team may add a Player to its Roster through one of the following mechanisms:

- A. Distribution Process
- B. NWSL Draft
- C. Trade
- D. Discovery
- E. Waiver Wire
- F. National Team Replacement Player
- G. Short-Term Injury Replacement
- H. Season-ending Injury Replacement
- I. Goalkeeper Replacement

For a Team to add a Player to its Roster, it must use one of the above mechanisms. Once it has been determined that a Player may be added pursuant to one of the above mechanisms, it must then be determined if the Player's addition would be within the relevant Roster limits and guidelines.

A.Distribution Process

Purpose and Intent

The intent of the Distribution Process is to provide an equitable mechanism for distributing the rights to certain Individuals to Teams in the NWSL.

Types of Individuals Available for Distribution

The following types of Individuals will have their Rights distributed to Teams via the Distribution Process:

1) An Allocated Player whose Rights have not yet been assigned to an NWSL Team

2) When a Player comes off Allocation and the Team chooses to relinquish its Rights to the Player

3) An Individual who is part of the USWNT Player Pool, who is not on the Discovery List of a Team and does not have their Rights controlled by a Team.

Collectively, these types of Individuals will be referred to as "Distribution-Eligible Individuals".

B. NWSL Draft

Individuals must be registered by the date set forth by the League to be part of the NWSL Draft. If an Individual is eligible and does not register, that Individual will not be able to be on the Roster of a Team until the start of the next League Year, at which point the Individual will become Discovery Eligible.

Eligibility

In order to be eligible for the upcoming NWSL Draft an Individual must:

- 1. Be a citizen or permanent resident of the United States, or a foreign national, who is currently or was enrolled at a university in the United States during the 2021-22 academic year;
- 2. Be an Individual who has exhausted, lost, or renounced their remaining collegiate eligibility during the 2021 calendar year, including high school graduates choosing to forego;
- 3. Be at least 18-years old by the conclusion of the NWSL League Season following the Draft;
- Not be under a current professional contract, nor have previously signed a contract to play soccer professionally; and
- 5. Register for the NWSL Draft by the registration deadline.

Draft Order

The draft order will be determined by the reverse order of finish of the most recently completed NWSL regular season, taking the Championship match into account. Specifically, the last ranking will go to the winner of the NWSL Championship, second to last ranking to the Championship runner-up and the 1st ranking will be provided to the Team with the lowest position in the NWSL table. Expansion Team(s) will be placed in the draft order as determined by the NWSL Board of Governors (as recommended by the Product Committee).

On the Monday following the NWSL Championship the League will confirm the NWSL Draft order by assigning selection numbers to conditional picks acquired via trade.

College Protected Period and College Protected List (all Drafts except 2021)

Protected Period. The NWSL Playing Rights to any Players selected in the NWSL Draft shall be assigned to the drafting Team's College Protected List immediately following the Draft until the end of the End of Season Process (the "Protected Period"), except as noted below. Rights to Players on a Team's College Protected List are assets of the Team and may be kept, waived or traded, at the Team's discretion, during the Protected Period. If waived, and not picked up off the Waiver Wire by another Team, the Player becomes Discovery Eligible.

Preseason Requirement. A drafted Player shall be invited to participate in NWSL preseason training by the Team that drafted her in the season immediately following the Draft in which she was selected.

Standard Player Agreement. A Player on a drafting Team's College Protected List is not on the Team's Roster and may not play for the Team unless and until she is offered and signs a SPA. If a Player is drafted by a Team in the Draft and the Team wants to add that Player to its Roster, the League will attempt to sign the Player to a SPA. There is no guarantee that a drafted Player will be offered or will agree to sign a SPA with NWSL. Once a drafted Player signs a SPA, the Player moves to the Team's Roster and does not return to the Team's College Protected List, unless the Player was signed as a short-term replacement player. If a drafted Player is not offered a SPA, she will remain on the drafting Team's College Protected List through the Protected Period unless sooner waived or traded. If a Player is offered a SPA during the Protected Period but does not sign it, or chooses not to attend pre-season training once invited, she shall remain on her drafting Team's College Protected List until the beginning of the preseason in the upcoming League Year and will then become Discovery Eligible.

For example, if a Player is selected in the 2022 NWSL Draft by a Team, offered an SPA and subsequently does not sign the SPA during the Protected Period, that Player will remain on the Team's College Protected List until the day before the 2023 preseason, and then be Discovery Eligible.

End of Protected Period

- 1. A Player not offered a SPA, and not traded or waived will process through the End of Season Process and if unclaimed will become Discovery Eligible.
- 2. A Player who is offered a SPA but does not sign it, or chooses not to attend pre-season training once invited, will become Discovery Eligible on the first day of the preseason of the upcoming League Year.

NOTE: A Team claiming a Player off the Waiver Wire assumes the Player's existing SPA but may renegotiate with the Player. If the Player does not have a current SPA, the Team claiming the Player's Rights must submit a PAF within fourteen (14) days or the Player will be waived. If the Player is currently under contract in another league and not within six (6) months of the end of her contract, the fourteen (14)- day window will begin once the Player is within six (6) months of the end of her current contract.

College Protected Period and College Protected List (2021 NWSL Draft)

Protected Period. The Rights to any Players selected in the NWSL Draft shall be assigned to the drafting Team's College Protected List immediately following the Draft until the start of the following NWSL preseason, except as noted below. Rights to Players on a Team's College Protected List are assets of the Team and may be kept, waived or traded, at the Team's discretion during the Protected Period. If waived, and not picked up off the Waiver Wire by another Team, the Player becomes Discovery Eligible. Rights to Players on a Team's College Protected List who have not been traded, waived or offered an SPA at the end of the Protected Period shall be waived.

Preseason Requirement. A drafted Player shall be invited to participate in NWSL preseason training by the Team that drafted her in the season immediately following the Draft in which she was selected.

Standard Player Agreement. A Player on a drafting Team's College Protected List is not on the Team's Roster and may not play for the Team unless and until she is offered and signs a SPA. If a Player is drafted by a Team in the Draft and the Team wants to add that Player to its Roster, the League will attempt to sign the Player to a SPA. There is no guarantee that a drafted Player will be offered or will agree to sign a SPA with NWSL. Once a drafted Player signs a SPA, the Player moves to the Team's Roster and does not return to the Team's College Protected List, unless the Player was signed as a short-term replacement player. If a drafted Player is not offered a SPA, she will remain on the drafting Team's College Protected List through the Protected Period unless sooner waived or traded. If a Player is offered a SPA during the Protected Period but does not sign it, or chooses not to attend pre-season training once invited, she shall remain on her drafting Team's College Protected List until the beginning of the preseason in the upcoming League Year, and then will be placed on the Wavier Wire.

For example, if a Player is selected in the 2021 NWSL Draft by a Team and offered an SPA and subsequently does not sign the SPA during the Protected Period, that Player will remain on the Team's College Protected List until the day before preseason in 2022.

End of Protected Period

- 1. A Player not offered a SPA, and not traded or waived, will be placed on the Waiver Wire at the beginning of preseason of the next League Year.
- 2. A Player who is offered a SPA but does not sign it, or chooses not to attend pre-season training once invited, will become Discovery Eligible on the first day of the preseason of the upcoming League Year.

A Team claiming a Player off the Waiver Wire assumes the Player's existing SPA but may renegotiate with the Player. If the Player does not have a current SPA, the Team claiming the Player's Rights must submit a PAF within fourteen (14) days or the Player will be waived. If the Player is currently under contract in another league and not within six (6) months of the end of her contract, the fourteen (14)-day window will begin once the Player is within six (6) months of the end of her current contract.

Undrafted Individuals

An Individual who is eligible for the NWSL Draft and is undrafted becomes Discovery Eligible on the day following the conclusion of the Draft.

Note: per NCAA legislation, undrafted Individuals may return to school and retain their collegiate eligibility if they notify their institution's Director of Athletics within seventy-two (72) hours following the Draft.

C. Trades

Players may be acquired in trades with League approval.

All Player trades are subject to League approval and to Salary Cap and Roster requirements. Player trades cannot be made for finite periods (i.e., Players may not be "loaned" by one Team to another), nor may a Team structure a trade such that a Player may not play against her previous Team.

Trades may not be conditioned upon a Player passing a physical examination or voided because she failed to do so – it is a case of "buyer beware." Teams are advised to undertake any inquiries regarding a Player's medical condition before executing a Trade Agreement. It is also a case of "buyer beware" regarding a Player failing to report to her new Team. It is the responsibility of the Team acquiring a Player to assume all terms of the Player's current SPA.

Bona fide consideration (e.g., an exchange of Players, Rights, future Draft choices, Allocation Money, international Roster spots) is required in each trade of a Player. Tradeable assets may be traded for the current League Season (or the upcoming League Season if it is currently the Offseason), plus three additional League Seasons. International Roster spots may be traded for one (1), two (2), three (3) years or in perpetuity.

For example, during the 2021 League Season, a Team may trade assets for the 2021, 2022, 2023 and 2024 League Seasons.

Binding Agreement and Approval

A trade is binding on the Teams from the time the Trade Agreement Form is executed by both Teams and submitted to the League, but is not final until approval has been received in writing from the League. Once the League has given approval, the trade is final, except where, in the opinion of the League, egregious conduct has occurred on the part of a Team involved in a trade that was not known at the time the trade was approved.

The League shall deny any trade of a Player if the consideration is not clearly established and accurately disclosed on the Trade Agreement Form submitted to the League. The Teams will then have the opportunity to amend the language in the Trade Agreement Form and resubmit to the League.

Trades of Discovery Players

Teams may not trade Discovery Players.

Trades of Discovery Spots

Teams may not trade Discovery Player spots.

Trades for International Roster Spots

Teams may trade international Roster spots, provided that the only condition can be the length of time the spot is traded. International Roster spots may be traded for one (1) year, two (2) years, three (3) years or in perpetuity.

Trades for NWSL Draft Picks

Teams are permitted to trade selections for the upcoming or current NWSL Draft, and the next three (3) NWSL Drafts.

Trades for Distribution Draft Ranking Spot

Teams may trade their Distribution Ranking Spot, provided part of the compensation received in return is the other Team's Distribution Ranking Spot. No Team may hold more than one Distribution Ranking Spot.

Trades for Allocation Money

Teams are permitted to trade Allocation Money for the current League Season, (or the upcoming League Season if it is currently the Offseason) and the next three (3) League Seasons.

Trade Deadline

No trade may take place between Roster Freeze and the NWSL Championship.

Standard Trade Agreement Forms

All trades shall be submitted to the League on an official Standard Trade Agreement Form.

D. Discovery

Discovery is the mechanism by which Teams secure the exclusive right within the NWSL to negotiate the terms of a SPA with an Individual on behalf of the League. The intent of the rule is to facilitate the signing of Discovery Players to SPAs with the NWSL. The NWSL reserves the right to reject any Discovery Player Request or to nullify the rights any Team may have to a Discovery Player in the event it determines, in its sole discretion, that a Team is acting in a manner inconsistent with the intent of this rule, or if future rule changes necessitate the removal of the Discovery Player from a Team Discovery List.

An Individual must be placed on a Team's Discovery List prior to any communication with the Individual.

Definitions

Club: a soccer club that participates in a professional or amateur women's soccer league other than the NWSL.

Competing Discovery Request: the process that Teams may initiate to secure an Exclusive Period with a Discovery Player who is on another Team's Discovery List.

Discovery List: the list maintained by the NWSL of a Team's current Discovery Players. Each Team's Discovery List is confidential and will not be shared with other Teams.

Discovery Player Request Form: the standard form utilized by Teams to request an Individual be added to a Team's Discovery List.

Discovery Ranking: a list of Teams that is used to determine the Team that shall receive priority when two or more Discovery Requests for the same Individual are made simultaneously.

Discovery Request: the submission of a Discovery Player Request Form to the NWSL.

Exclusive Period: after a Team adds an Individual to its Discovery List, or successfully initiates a Competing Discovery Request, it will be granted an "Exclusive Period" during which other Teams are prohibited from submitting a Competing Discovery Request. The duration of the Exclusive Period shall be seven (7) days, unless the Competing Discovery Request in initiated during the secondary transfer window, in which case it shall be five (5) days.

Discovery List

Teams may have a maximum of seven (7) Discovery Players, including any combination of domestic and international players, on their Discovery List at any time.

Teams may remove a Discovery Player from their Discovery List at any time by submitting a request via email to the NWSL. Once removed, the Individual immediately becomes Discovery Eligible by all Teams.

Teams may add Discovery Eligible Individuals to their Discovery Lists at any time. Discovery Lists are perpetual; they do not reset at any time.

Discovery Players will be removed from a Team's Discovery List under any the following conditions:

- 1. The Discovery Player and NWSL fully execute a SPA;
- 2. Another Team wins a Competing Discovery Request for the Discovery Player; or
- 3. A Team notifies the League that it would like to remove the Discovery Player from its Discovery List.

Eligibility

Individuals are Discovery Eligible and may be added to a Team's Discovery List if they meet the following criteria:

- 1. The Individual does not currently have a valid SPA with the NWSL;
- 2. The Individual does not have their Rights controlled by a Team;
- 3. The Individual is not eligible for a current or future NWSL Draft, as determined by the NWSL;
- 4. The Individual is at least 17 years of age; and
- 5. The Individual is not in the USWNT Player Pool.

Individuals in the USWNT Player Pool may only be acquired via the Distribution Process.

If a Team accepts a transfer fee in conjunction with the transfer of a Player to a Club, that Team is prohibited from adding that Individual to their Discovery List until twelve (12) months have elapsed from the date of the executed Transfer Agreement.

For a period of twenty-four (24) hours after the expiration of a loan, the Player loaned to a Team by a Club will be Discovery Eligible exclusively by that Team.

Discovery Request Process

An Individual must be Discovery Eligible at the time a Team submits a Discovery Player Request Form to the League. If a Discovery Player Request Form is submitted "in advance" or otherwise prior to the Individual being Discovery Eligible, the Discovery Request will be rejected.

A Team must have and maintain space on its Discovery List for the Individual from the time the Discovery Player Request Form is submitted until such time it is approved (in which case the Individual will occupy the open space of the Discovery List), rejected, or withdrawn.

To add an Individual to a Team's Discovery List, the Team must complete a Discovery Player Request Form and submit it to the NWSL for consideration.

The NWSL will consider Discovery Requests in the order received, with the Team submitting the Discovery Player Request Form first (based on the exact date and time the Discovery Player Request Form was received via email by the NWSL) receiving priority. In the event two or more Discovery Requests are submitted simultaneously, the NWSL will consider the request of the Team with the highest Discovery Ranking, and the other Discovery Request will be rejected. The Team with the highest Discovery Ranking will then be moved to the lowest spot in the Discovery Ranking.

Based on the criteria described above under "Eligibility," the NWSL will approve or reject the Discovery Request.

- 1. If the Individual is not Discovery Eligible, the Discovery Request will be rejected, and the Team will be provided the rationale employed by the NWSL for rejecting the Discovery Request.
- 2. If the Individual is Discovery Eligible, the Discovery Request will be approved, and the Individual will be added to the Team's Discovery List.
- 3. If the Individual is already on another Team's Discovery List, but the Discovery Request was made within the Exclusive Period, the following steps will be taken:
 - The NWSL will reject the Discovery Request;
 - The NWSL will inform the Team that the Individual is already on the Discovery List of another Team (without identifying which Team); and
 - Inform the Team of the date the Exclusive Period ends.
- 4. If the Individual is already on another Team's Discovery List, and the Discovery Request was submitted after the Exclusive Period has expired, the following steps will be taken:
 - The NWSL will reject the Discovery Request;
 - The NWSL will inform the Team that the Individual is already on the Discovery List of another Team (without identifying which Team), and
 - If the Team wishes to initiate a Competing Discovery Request it will resubmit the Discovery Request Form by 6:00 pm ET on the following business day, indicating the Competing Discovery Request.

If the Discovery Player Request is approved, beginning the day after the Individual is approved and added to a Team's Discovery List, the Team will have an Exclusive Period to submit a PAF to the NWSL (and transfer or loan documents, if applicable) before other Teams are permitted to initiate a Competing Discovery Request for the Discovery Player.

The NWSL will take the following actions after receiving a PAF from the Team:

- 1. Determine whether the offer is bona fide. If the offer is not deemed bona fide it will be rejected.
- 2. Establish the current contract status of the Discovery Player, with assistance from the Team submitting the PAF.
- 3. Issue a SPA to the Discovery Player if one of the following conditions are true:
 - The Discovery Player is currently out of contract;
 - The Discovery Player is under a contract with a Club that will expire within six months; or
 - The Discovery Player is under contract with a Club and the term of that contract does not expire within six months, but the Team can provide written proof that it has permission from the Club to engage in contract discussions with the Discovery Player, and provide transfer or loan documents.
- 4. If the PAF is submitted after the Roster Compliance date, the Team attempting to sign the Discovery Player to a SPA must notify the League of the measures it will take to remain Roster compliant, if any such moves are necessary.

If the Discovery Player and NWSL do not fully execute a SPA that was issued pursuant to one of the scenarios described above, after 30 days the SPA will be rescinded, and the Discovery Player remains on the Team's Discovery List.

If after receiving a PAF from the Team, the League determines the Discovery Player may not be issued a SPA, the Discovery Player will remain on the Discovery List of the Team (e.g., Discovery Player has more than six (6) months remaining on her contract and her current Club does not agree to transfer the Discovery Player).

Competing Discovery Request Process

Once the Exclusive Period for a Discovery Player has expired, other Teams may initiate a Competing Discovery Request.

Each Team is limited to initiating a total of five (5) Competing Discovery Requests per calendar year. If a Competing Discovery Request is made such that its Exclusive Period extends into the following calendar year, it shall only count against the Team's permitted Competing Discovery Requests for the calendar year in which it was first initiated.

When the NWSL receives a Discovery Player Request from a Team (the "Competing Team") for a Discovery Player who is already on the Discovery List of a Team (the "Original Team") for which the Exclusive Period has expired, the NWSL will require the Competing Team to indicate its choice in writing by resubmitting its original Discovery Player Request Form by 6:00 pm ET on the business day following notification from the NWSL with their choice of either (a) withdrawing its Discovery Request, or (b) initiating a Competing Discovery Request. Should a Team inform the NWSL that it wishes to initiate a Competing Discovery Request, the Team shall be deemed to have used one (1) of their five (5) permitted Competing Discovery Requests for the current NWSL Season.

Teams wishing to initiate a Competing Discovery Request must have \$25,000 in Funded Allocation Money that shall remain unencumbered throughout the duration of the Exclusive Period. If the Competing Team does not satisfy this requirement within three (3) business days after initiating the Competing Discovery Request, the Competing Discovery Request will be rejected, but it will still count as one (1) of the Team's five (5) permitted Competing Discovery Requests for the current calendar year.

If a Competing Discovery Request is initiated, the Competing Team must maintain space on its Discovery List until it withdraws its request, the Exclusive Period expires, or the Discovery Player executes a SPA with the NWSL (in which case the Discovery Player will be automatically removed from the Competing Team's Discovery List).

The NWSL will notify the Original Team of the Competing Discovery Request within 24 hours of receipt and will provide the Original Team with the name of the Competing Team.

The Original Team will have an Exclusive Period — beginning the day after it is notified by the NWSL of the Competing Discovery Request — to take one of the following actions:

- 1. Submit a PAF (and transfer or loan documents, if applicable) to the NWSL that includes a bona fide offer with a start date no later than the last day of the current registration window, or the next registration window if a window is not currently open. If the offer is not deemed bona fide by the NWSL in its reasonable judgement, the Original Team may modify its offer (until the expiration of the Exclusive Period) by submitting one or more revised PAFs (terms of the PAF may not be changed once the Exclusive Period has expired) until the offer is adequate-to-be-deemed bona fide by the NWSL. In such case the Competing Discovery Request shall be rejected.
 - Relinquish the exclusive negotiating rights for the Discovery Player to the Competing Team.

If the Original Team does not successfully execute one of the options described above then at the end of the Exclusive Period, the Competing Team will be granted an Exclusive Period to negotiate with the Discover Player on behalf of the League. In return, the Original Team will receive \$25,000 in Funded Allocation Money (or another asset or assets as mutually agreed upon in writing by the Original Team and Competing Team and approved by the NWSL) from the Competing Team, immediately due and payable only in the event the Competing Team successfully concludes a SPA between the Discovery Player and the NWSL. The Competing Team must submit a PAF (and transfer or loan documents, if applicable) to the NWSL that includes a bona fide offer prior to the expiration of the Exclusive Period (terms of the PAF may not be changed once the Exclusive Period has expired).

If the Competing Team does not submit a PAF that includes a bona fide offer for the Discovery Player on or before the expiration of the Exclusive Period, the Competing Discovery Request shall expire, and all rights to the Discovery Player remain with the Original Team. In such case the Original Team will receive another Exclusive Period before a Competing Discovery Request may be initiated by another Team.

The NWSL will take the following actions after receiving a PAF from the Competing Team:

- 1. Determine whether the offer is bona fide. If the offer is not deemed bona fide it will be rejected.
- 2. Establish the current contract status of the Discovery Player, with assistance from the Team submitting the PAF.
- 3. Issue a SPA to the Discovery Player if one of the following conditions are true:
 - The Discovery Player is currently out of contract, or;
 - The Discovery Player is under a contract with a Club that will expire within six months, or;
 - The Discovery Player is under contract with a Club and the term of that contract does not expire within six months, but the Competing Team can provide written proof that it has permission from the

Club to engage in contract discussions with the Discovery Player, and provide transfer or loan documents.

4. If the PAF is submitted after the Roster Compliance date, the Team attempting to sign the Discovery Player to a SPA must notify the League of the measures it will take to remain Roster compliant, if any such moves are necessary.

If the Discovery Player and NWSL do not fully execute a SPA that was issued pursuant to the above, after 3 (three) days the SPA will be rescinded, and the Discovery Player remains on the Original Team's Discovery List.

A Competing Discovery Request may not be initiated for a Discovery Player who has returned to school to continue her collegiate eligibility, until the day following the conclusion of her collegiate career.

Discovery Ranking

The Discovery Ranking is determined by the reverse order of finish of the prior NWSL regular season, taking the Championship match into account. Specifically, the last ranking will go to the winner of the NWSL Championship game, the runner-up of the NWSL Championship game will be second to last, and the 1st ranking will be provided to the Team with the lowest position in the NWSL table. Expansion Team(s) will be placed in the Discovery Ranking as determined by the NWSL Board of Governors (as recommended by the Product Committee).

The Discovery Ranking is confidential and may not be disseminated or discussed with any person that is not an employee, contractor, or otherwise directly affiliated with the NWSL or one of its Teams without prior written approval of the Commissioner.

NWSL Draft / Draft-Eligible Individuals

Beginning with the day following the NWSL Draft, Teams may add Individuals to their Discovery List who were registered for the NWSL Draft but were not selected by a Team.

Individuals who were eligible to register in the NWSL Draft in the upcoming or current calendar year, but instead elected to sign a professional contract with a Club, are not Discovery Eligible until the day following the NWSL Championship that takes place during the year they were eligible to register for the NWSL Draft.

E. Waiver Wire

Players may be added to a Team's Roster from the Waiver Wire, which is distributed by the League via e-mail (See Waiver). A Team may not claim a Player it waived in the same Waiver Wire.

F. National Team Replacement Player

If a Player is called up for national team duty, a Team may add a National Team Replacement Player to count toward the 22-Player Roster minimum. The National Team Replacement Player's salary will not count against the Team's Salary Cap. National Team Replacement Players must be released when the national team Players are back to full participation with the Team. This includes goalkeepers called up fr national team duty.

A PAF must be submitted and National Team Replacement Player will sign a SPA. They must be registered as a professional player with USSF.

For each national team call-up, each Team will need to submit PAFs for National Team Replacement Players no less than five (5) days prior to the Player's participation in League-sanctioned competition with the Team.

- 1. The salary provided for the National Team Replacement Player must be the League Minimum Salary;
- 2. The Player must be a Domestic Player;
- 3. The Player must complete an entrance physical and pass an exit physical;
- 4. The Player will remain under contract for the period of time the national team Player is unavailable. Upon such time that the national team Player is no longer with her respective national team and can return to play, the SPA for the Player will be terminated.
- 5. The National Team Replacement Player will not enter the League through Discovery and will not exit the League through the Waiver Wire. Should the Team who has the National Team Replacement Player on its Roster be interested in submitting a Discovery Request for the National Team Replacement Player, it may

do so while the Player is under contract as a National Team Replacement Player. If the Player does not remain on the Roster of the Team, she becomes Discovery Eligible the day after her SPA is terminated.

• If a Team wishes to keep a National Team Replacement Player on its Roster following the return of Players from national team duty, the Team must notify the League in writing. The Team is not required to Discover the Player for her to remain on the Team's Roster.

G. Short-Term Injury

Where the League determines (based on certification from a Team's physician) that a Player has sustained an injury that will prohibit the Player from participating for at least 45 days, but not the entire length of the season, she may be placed on the 45-Day Disabled List. A Player may only be on the 45-Day Disabled List during the League Season. A Player who has not been cleared for full activity and participation by the Team physician may remain on the 45-Day Disabled List longer than 45 days.

A Team will be provided Roster relief for a Player on the 45-Day Disabled List and will be able to sign a Disabled List Replacement Player but will not receive Salary Cap relief for the Player. As such, any new Player signed to replace the injured Player must fit within the Team's Salary Cap. Disabled List Replacement Players must be signed prior to the Roster Freeze Date. Any Player coming off the Disabled List following the Roster Freeze Date may be added to the Roster, but Teams must comply with the relevant Roster limits.

Unexpected Recovery from Short-Term Injuries

In the event a Player who has sustained a physician-certified short-term injury recovers earlier than anticipated, she will not be permitted to join the active Roster prior to the end of the 45-day period.

H. Season-Ending Injury

Where the League determines (based on certification from a Team's physician) that a Player has sustained an injury that will prohibit the Player from participating for the remainder of the League Season, she may be placed on the Season-Ending Injury List. A Player may be on the Season-Ending Injury List at any point during the League Year.

In the event of such a determination, the injured Player shall not be eligible to play for the Team again during the then current League Season, except as detailed below, and the League will provide the Team Roster relief and Salary Cap relief and will be able to sign a Disabled List Replacement Player. Teams will receive Salary Cap relief for each day the Player is on the Season-Ending Injury List, up to the full amount of the Player's salary or the League Maximum Salary, whichever is lowest. If the Player suffering the Season-Ending Injury is an International Player, the Team may replace such Player with an International Player.

Disabled List Replacement Players must be signed prior to the Roster Freeze Date. Any Player coming off the Disabled List following the Roster Freeze Date may be added to the Roster, but Teams must comply with the relevant Roster limits. The budget number for the Disabled List Replacement Player will be calculated in the same manner as any other Senior Roster Player and counts against the Team Salary Cap.

A Player on the Season-Ending Injury List at the conclusion of the League Season may remain on the Season-Ending Injury List into the next League Season and continue to accrue Salary Cap relief and Roster relief. Once cleared by the Team physician for full participation (even if after the Roster Freeze date), the Player may join the active Roster and does not count as one of the two (2) Players returning from Season-Ending Injury as detailed below. The Player ceases to accrue Salary Cap relief and Roster relief when she is cleared for participation by the Team physician.

Unexpected Recovery from Season-Ending Injuries

In the event a Player who has sustained a physician-certified season-ending injury recovers prior to the end of the League Season, she will be permitted to join the active Roster through the remainder of the League Season, so long as the Team did not previously accept neither Roster nor Salary Cap relief for the Player. A maximum of two (2) Players may return from the Season-Ending Injury List during each League Season.

I. Goalkeeper Replacement

Teams are required to carry a minimum of two (2) goalkeepers on their Rosters throughout the League Season.

In the case of an injured goalkeeper, or where its Team has less than two available goalkeepers, a Team must add a goalkeeper to its Roster until a goalkeepers are back to full participation with the Team. If the goalkeeper is an International Player, the Team may replace such goalkeeper with an International Player.

This must be done within the Salary Cap.

METHODS OF RELEASING PLAYERS

A. Waiver

Teams may waive Players based on performance at any time prior to the Roster Freeze date during the NWSL Season, subject to Guaranteed SPA restrictions.

A Team wishing to waive a Player must first obtain a favorable medical examination of the Player – an "exit physical", and then submit its Waiver Request Form to the League.

Once a Player on a P-1 visa has been waived and is not picked up by another Team in the League via the Waiver Wire, the League is obligated to notify the United States Citizenship and Immigration Services (USCIS) of the termination of the employment relationship and the Player is required to depart the country. After that date, if another Team intends to add the Player to its Roster, it will need to file a new petition.

Waiver Wire

Provided the League approves a Player being placed on the Waiver Wire pursuant to the above, it will distribute a waiver notice to all Teams. A Team claiming a Player must notify the League of the measures it will take to remain Roster compliant, if any such moves are necessary. Notice must be received by the League from a Team claiming a waived Player within the "Waiver Claiming Period."

The "Waiver Claiming Period" shall commence on the first business day (the "Waiver Period Commencement Date") the League gives notice to Teams and shall expire at 6:00 pm ET on the first business day after the Waiver Period Commencement Date (the claiming period is 24 hours). If the waiver notice is distributed on Friday, the Waiver Claiming Period closes on Monday.

If a Team claims a Player and no other Team claims the same Player during the Waiver Claiming Period, the Player shall be assigned to the claiming Team. If more than one Team claims a Player during the Waiver Claiming Period, the Waiver Order Tie Breaker will be used.

Waiver Order Tie Breaker

The Waiver Order is determined by the reverse order of finish of the prior NWSL regular season, taking the Championship match into account. Specifically, the last ranking will go to the winner of the NWSL Championship game, the runner-up of the NWSL Championship game will be second to last, and the 1st ranking will be provided to the Team with the lowest position in the NWSL table. Expansion Team(s) will be placed in the Waiver Order as determined by the NWSL Board of Governors (as recommended by the Product Committee).

Once all Teams have played at least three (3) regular season games in the following season, the Waiver Order will be the reverse order of the table at the time the Waiver Request Form is received, including expansion Teams as appropriate. Prior to all Teams playing three (3) games in the regular season, a Team only moves to the bottom of the Waiver Order if the tie breaker is utilized.

B. SPA Expiration

When a Player's SPA expires, the Player is processed through the End of Season Process to determine her future SPA status or Rights assignment.

C. Buyout of Guaranteed SPA

A Team may buyout one (1) Guaranteed SPA in a League Season that will not count against the Team's Salary Cap, subject to League Policy.

D. End of Season Process

After the conclusion of the season, Teams must decide which Players they no longer wish to retain and specify the action required to release them based on their SPA status on the End of Season Process decision sheet. Players are submitted to the End of Season Waiver Wire by indicating the following actions based on the Player's current SPA status:

The End of Season Waiver Wire shall commence on the first business day after the League delivers notice to Teams of its commencement and expires at 6:00 pm ET on the second business day after the End of Season Waiver Wire commencement date.

E. Player Elected Leave

A Player may request a leave of absence from services required under the SPA. If approved by the League, the Player's Rights will continue to be held by the Team for whom she last played, through the term of her SPA. The Player will receive compensation per the terms of the SPA for the services provided through and including the effective end date of her service prior to her leave of absence. Any remaining salary beyond the effective end date will not be charged to the Team's Salary Cap.

V. RULES & REGULATIONS

A. Player Registration and Participation

All Players in the NWSL must be registered with USSF prior to participating in any competition and their ITC requested and received by USSF.

A Player wishing to participate in a non-NWSL and/or non-Team event must first receive written permission from her Team and then written permission from the League before agreeing to participate.

Player participation in a Team event not sanctioned by the League is voluntary and must be disclosed to the League.

Registration Moratorium

The deadline to submit a PAF for a new SPA during the League Season will be as follows:

- 1. For any weekday game (Monday-Friday), the PAF must be received by the League by 6:00 pm ET on the day before the game (e.g., if the game is on Wednesday, the PAF must be received by the League before 6:00 pm ET on Tuesday).
- 2. For Saturday and Sunday games, the PAF must be received by the League by 1:00 pm ET on the Friday prior to the weekend (e.g., if the game is on Sunday, the PAF must be received by the League before 1:00 pm ET on Friday).

Submitting a PAF to the League does not guarantee a Player will be eligible to complete in the Team's next competition; all other registration requirements (e.g., Roster and Salary Cap compliance, receipt of the Player's ITC, etc.) must be met prior to a Player being eligible to play in a League match.

Out of Contract Players

With respect to Players not under contract, they may be able to be registered outside the transfer windows, provided the Player was out of contract during NWSL's immediately previous registration window. A Player who has secured a release from an existing contract or the contract has expired outside a NWSL registration window may not be transferred to the League unless or until the transfer window is open.

Drafted Players

Domestic Players selected in the NWSL Draft, may be signed and registered outside the transfer window, provided their ITC has not been transferred outside the U.S.

With respect to International Players selected in the NWSL Draft, the Player's ITC may be subject to the Transfer Windows and may have potential work permit issues.

B. Transgender Players

The NWSL is committed to creating a safe, non-discriminatory, and inclusive environment for all of its Players while maintaining competitive equity throughout the league.

The following guidelines set out the NWSL's eligibility policy.

Definitions:

"Gender identity" A core, hard-wired component of a person's identity as male, female, or anywhere else on the gender spectrum. This identity may or may not match the gender that the person was assigned at birth. *Everyone has a gender identity*.

"Gender expression" How a person expresses their gender through outward presentation and behavior, including a person's name, clothing, hair style, and mannerisms. Gender expression is not necessarily an indication of gender identity, assigned gender, or sexual orientation.

"Transgender" A person whose sex at birth is different from who they know they are on the inside. It is used as an adjective to describe someone, as in "a transgender person" or "a person who is transgender." It is offensive to use this word as a noun (i.e., transgenders) or a verb (i.e., transgendered).

"**Transition**" The process by which a person brings their body and gender expression into alignment with their gender identity. That process does not make a transgender person more of a man or more of a woman than they were before. Rather, a person's gender identity is innate and already exists, just as it does for non-transgender people. The only purpose of a transition is to help a transgender person express their innate identity and help others recognize that identity; it does not change that person's identity.

Eligibility Guidelines:

- 1. People designated female at birth, regardless of their gender identity or gender expression, are eligible to compete in the NWSL, subject to the guidelines herein and other eligibility criteria of the NWSL.
- 2. Athletes designated female at birth who are transitioning to male who undergo testosterone hormone therapy will be ineligible to compete in the NWSL.
 - Notwithstanding the foregoing, athletes designated female at birth who identify as male (transgender men) who are not undergoing testosterone hormone therapy may be allowed to take low doses of testosterone while competing in the NWSL if:
 - the athlete's total testosterone level in serum is within typical limits of women athletes (as set forth in Section 3.b. below), and
 - such use is pursuant to a therapeutic use exception as determined by the NWSL in its sole discretion, in consultation with the athlete's physicians and applicable medical experts.
- 3. Athletes who transition from male to female are eligible to compete under the following conditions:
 - The athlete has declared that her gender identity is female. The declaration cannot be changed, for sporting purposes, for a minimum of four years from the declaration.
 - The athlete must demonstrate that her total testosterone level in serum is within typical limits of women athletes (the current standard is below 10 nmol/L; subject to change based on the most up-to-date medical and expert information available at the time of implementation) for no less than twelve (12) months prior to competition so as to minimize any potential competitive advantage. This may be accomplished through androgen-suppressing treatments or a gonadectomy.
 - The athlete's total testosterone level in serum must remain in the typical range of women athletes throughout the period of desired eligibility to compete in the NWSL.

 Compliance with these conditions may be monitored by testing, which testing shall be administered in the NWSL's sole discretion based on standards of reasonableness and fairness and in consultation with physicians and medical experts as selected by the NWSL. In the event of non-compliance, the athlete's eligibility in the NWSL will be suspended for 12 months.

Process:

Athletes currently participating or seeking to participate in the NWSL who wish to make changes to their current gender identity, name, pronoun, or other markers should contact: Aries Pickett, NWSL's Senior Manager, Talent & Administration at apickett@nwslsoccer.com, to begin the process and to assist in making these changes on official publications and listings.

Any athlete applying to participate under the NWSL Policy on Transgender Athletes will be required to permit their treating medical doctor to disclose relevant medical information to the NWSL (including such information, records or other material as the NWSL may reasonably require from time to time) and to permit the NWSL to discuss medical information with the treating medical doctor as necessary.

The NWSL understands that the situation of each athlete may vary and that subject matters addressed herein are highly sensitive in nature. Therefore, in order to make a determination regarding participation in the NWSL under this policy, each player evaluation conducted pursuant to this policy will be addressed on a case-by-case basis. The legitimate privacy interests and legal rights of all athletes will be respected at all times. Ultimately, the NWSL has sole and absolute discretion with respect to all decisions and/or determinations made herein.

If a Player's Gender Is Challenged:

For the avoidance of doubt, eligibility determinations for transgender Players will be made prior to each NWSL season in a similar manner as eligibility determinations made for all other Players in the NWSL, and incorporating the same presumption of eligibility. If an NWSL team or Player believe that an Player was improperly deemed eligible under this policy, they may request a review of that Player's eligibility. That request must be made formally and in writing, setting out clearly the grounds on which the request is based. Any such requests filed during the NWSL's regular or post season will be reviewed prior to the start of the following season in conjunction with the NWSL's annual eligibility determination for all other Players.

The NWSL will only consider requests that are reasonable and made in good faith. In the event that a request to review a transgender Player's eligibility provides a credible basis for doing so, the NWSL will work with the transgender Player to undertake a sensitive review of their circumstances and shall have the authority to take all appropriate measures for the determination of the gender of the Player under this policy.

Confidentiality:

All of the information and documents related to the eligibility of a transgender athlete will be treated as highly confidential. The parties agree that they will not at any time disclose such information or documents (other than in the ordinary and usual course of implementing this policy) without the prior written consent of the disclosing party, unless required by law.

C. Player Tryouts and Training

No tryouts may be conducted by a Team unless they are done pursuant to this Section. A tryout shall include any practice, participation, or training: (a) with any Individuals; and (b) under the direct or indirect supervision of an Team coach, trainer, or other member of a Team's management. No Team may conduct a tryout with an Individual unless she has executed a Waiver of Liability Agreement.

Names of all Individuals that are practicing with Teams throughout the season must be submitted to the League.

Teams may not try out a Player whose Rights are held by another Team without League approval. No Team may try out an Individual under contract to a club outside NWSL without the written approval of the League. Players with a current SPA may not participate in tryouts.

D. Preseason

Teams may commence preseason training on the date set out in the Competition Calendar. A training session shall include any practice, participation, or training: (a) with any Players under contract to NWSL; or (b) with any Individuals listed on the Team's preseason Roster under the direct or indirect supervision of an NWSL coach, trainer, or other member of a Team's management.

A Player or Individual must be on an official NWSL preseason Roster to participate in Practice Games or Exhibition Games.

E. Practice and Exhibition Games During the Regular Season

Teams may hold Practice Games and Exhibition Games during the regular season with prior notice to and approval from the League. A Practice Game or Exhibition Game Roster must be submitted at least 48 hours in advance to the League for approval and may not exceed a maximum of 28 Players.

Teams will be allowed to use Individuals in Practice Games. Any Individual must sign a Release and Liability Waiver in advance, and if they are under 18, their parent or guardian must sign as well. Teams will be allowed to use Individuals in Exhibition Games involving a college/university opponent. Otherwise, only contracted Players may participate in Exhibition Games involving professional team opponents. All Individuals involved in a Practice Game or Exhibition Game must follow NWSL Medical Protocols
