1. Purpose

The Board, through the Constitution, is entitled to exercise all powers of UN Youth. In practice, the Board empowers the National Executive to operate the organisation on a day-to-day basis through the delegation of adequate authority that is required to execute the operations of UN Youth. The National Executive can reasonably exercise this delegation within the specific limitations on the authority delegated to management outlined in this policy.

This delegation of authority continues down via line management to the volunteers who perform particular aspects of UN Youth's business. The National Executive is accountable to the Board for the exercise of authority delegated to management.

1.1. Global delegation statement

The Board delegates to all officeholders all of their responsibilities, duties and powers, necessary for them to perform their roles, subject to the restrictions set out in sections 2-11 below and UN Youth's Policies and Protocols.

1.2. Policy and protocol

UN Youth has policies and procedures, which provide further information relating to many of the authorities contained in this document. It is the responsibility of all officeholders to read, and be familiar with the contents of all policies and procedures.

Where there is an apparent conflict or ambiguity between rules stated in a Policy and Procedure document, and those in this document, the more stringent control standard shall always apply.

4. Income

Delegate Attendance Fees are normally established and approved through the event budgeting process.

5. Sponsorship and External Relations

All sponsorship, partnerships and other external relationships must be consistent with UN Youth's values and purpose, and comply with applicable internal approvals. Where there is any risk of reputational harm the NRO must not approve the relationship without the approval of the Board.

All sponsorship, partnerships and other external relationships must only be secured and agreed in accordance with UN Youth's Policies and Protocols.

6. Expenditure

The delegations for expenditure below relate to the approval of invoices and receipts within UN Youth's accounting package. Any expenditure above these limits must be approved by the Board.

All expenditure must occur within approved event and region budgets.

Emergencies: In some rare circumstances, such as during events, a situation may occur that necessitates emergency expenditure outside of these limits on delegated financial authority. This must only occur on a UN Youth credit card in accordance with the Credit Card Procedure. The expenditure may only occur to mitigate or avoid adverse consequences for participants or UN Youth. This expenditure must be less than \$1000. The Board must be made aware of this additional expenditure immediately following the purchase.

Payment Approvals: The National Finance Officer will prepare a summary of planned payments for approval by the National Executive.

7. Supply Contracts

8. Human Resources

Volunteer Appointments: The National Executive, as a whole, have authority to appoint Level 5 Officeholders i.e. Assistant Event Directors, National Event Committee Members. The appointment of Level 3 and Level 4 Officeholders must be completed by the Board in accordance with the Volunteer Appointment Policy.

9. Media and Social Media

10. Record keeping

The National Executive is ultimately responsible for:

- Ensuring that appropriately detailed records of financial matters and decisions are kept
- Ensuring that, where appropriate, comprehensive records of all activities are kept and that these records:
 - Are accessible to appropriate persons;
 - o Respect the privacy of people, UN Youth and other where ethically or legally due;
 - Preserves and illuminates the history of UN Youth.

11. Matters specifically reserved to the Board

Decision-making on the following matters is retained by the Board and cannot be delegated (in addition to the specific authorities set out above):

- Establishment of Board Committees, and approval of their Terms of Reference;
- The appointment (and removal) and performance of the National Executive;
- Delegation to the organisation, and the scope and limitations of those delegations;
- Approval of the strategic plan, annual plan, and organisational budget;
- Authority to write off bad debts.

The Board retain all powers given to UN Youth through its constitution not reasonably required to manage the Operations of UN Youth .
