1. Purpose

The Board, through the Constitution, is entitled to exercise all powers of UN Youth.

This Policy is to ensure that the organisation generally, and all Officeholders, have all relevant powers to ensure it is able to execute the operations of, and implement strategic plans of, UN Youth.

2. Delegation

The Board delegates to all officeholders all of their responsibilities, duties and powers, necessary for them to perform their roles, subject to the general rules of delegation set out in section 3, and the restrictions set out in section 4 below, and excluding all matters which cannot be delegated as set out below.

The following matters are specifically reserved to the Board and cannot be delegated to an Officeholder:

- a) the power to appoint (and remove), and monitoring of performance of level 3 and level 4 Officeholders;
- b) the power to appoint Board directors;
- c) the power to approve a strategic plan, annual plan, organisational budget, or annual report;
- d) the power to establish Board subcommittees, and approval of their Terms of Reference;
- e) the power to write off bad debts;
- f) the power to delegate;
- g) any matter not permitted to be delegated by any Act.

UN Youth has policies and procedures, which provide further information relating to many of the authorities contained in this document. It is the responsibility of all officeholders to read, and be familiar with the contents of all policies and procedures.

3. General rules of delegation

- a) A responsibility, duty or power delegated to an Officeholder holding a named position or level of authority is also delegated to all Officeholders in a direct line of authority above that Officeholder;
- b) A responsibility, duty or power delegated to an Officeholder holding a named position is also delegated to any Officeholder who performs or exercises the same or a substantially similar role or function, whatever the name of his or her position;
- c) An Officeholder who is delegated a responsibility, duty or power is also delegated any ancillary responsibilities, duties or powers necessary to give effect to that delegation;
- d) Responsibilities, duties or powers delegated to Officeholders by the Board may not be sub-delegated;
- e) A delegation continues in force until it expires, is revoked, altered or varied by the Board (whichever is the earlier);
- f) An Officeholder must comply with any conditions (such as financial limits, and reporting or other procedural requirements) relevant to the exercise of a delegated authority, and must also comply where required with all applicable UN Youth policies and protocols;
- g) Where there is an apparent conflict or ambiguity between rules stated in a Policy and Procedure document, and those in this Policy, the more stringent control standard applies.

Note: the conferring of delegated authority means that the Officeholder *may* exercise the responsibility, duty or power, but not that he or she *should* do so (either at all, or in a particular case). Whether or not it is appropriate for an Officeholder to exercise a delegated authority which they have will depend on the particular circumstances, including:

- their role;
- the level of risk associated with the matter;
- the level of organisational or public interest in the matter; and
- any instructions given.

4. Restrictions on general delegation

The following functions, powers or duties may only be exercised by an Officeholder having the specified level of authority or higher (as defined in section 5):

4.1. Budgets
